Revocation of Insurance
Producer License Pursuant
to AS 21.27.440

ACCUSATION AND ORDER OF REVOCATION

1. On October 13, 2023, **ALEXANDRIA-ANDREA MOORE (MOORE)**, domiciled in the State of Florida applied for Insurance Producer License with the Alaska Department of Commerce, Community and Economic Development, Division of Insurance (Division) to transact the business of Health insurance. The Division issued license number 3002777282 and has an expiration date of April 30 on odd numbered years.
2. The Division received notice from National Insurance Producer Registry (NIPR) with an attached transaction log indicating **MOORE** has unsettled payment of \$75.00 for State licensing fee and \$5.60 for transaction fee totaling \$80.60 in unpaid license fees.

- 1 3. On February 12, 2024, the Division sent notice to **MOORE** informing her
2 of her unpaid license fees and gave **MOORE** until March 1, 2024, to
3 respond. No payment was received by the Division.
4
- 5 4. On April 18, 2024, the Division sent another correspondence to **MOORE**
6 of her unpaid fees, failure to respond, along with notice a revocation is in
7 order. No response was received.
- 8 5. Pursuant to Alaska Statute (AS) 21.27.040 which states that “(f) If,
9 through inaction, an applicant fails to complete the application process,
10 the applicant's application filed with the director under (a) of this section
11 is considered withdrawn...”
12
- 13 6. AS 21.27.410(a)(8) dictates, “the conduct of affairs under a license if the
14 licensee exhibits conduct considered by the director to reflect
15 incompetence or untrustworthiness, or to be a source of potential injury
16 and loss to the public;”
17
- 18 7. AS 21.27.010(a) also states in part that “...a person may not act as or
19 represent to be an insurance producer, managing general agent, or surplus
20 lines broker in this state or relative to a subject resident, located, or to be
21 performed in this state unless licensed under this chapter.”
22
- 23 8. Further, AS 21.27.440(a) provides that “in addition to any other penalties
24 provided by law, a person that the director of the division (director)
25 determines under AS 21.06.170-21.06.240 has violated the provisions of
26 this chapter is subject to (1) a civil penalty equal to the compensation
27 promised, paid, or to be paid, directly or indirectly, to a person in regard to

each violation; (2) either a civil penalty of not more than \$10,000 for each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license.”

IT IS HEREBY ORDERED, under the provisions of AS 21.27.440, that **MOORE’s** Insurance Producer license number 3002777282 is REVOKED for a period of one year.
