27 WHEREAS, a Certificate of Authority to transact the  
28 business of insurance in the State of Alaska has been issued to  
29 THE INTEGRAL INSURANCE COMPANY, domiciled in Missouri.

30 WHEREAS, the State of Missouri has placed THE  
31 INTEGRAL INSURANCE COMPANY under an Order of Rehabilitation  
32 dated September 17, 1991. The company remains in rehabilitation  
33 at the present time.

34 WHEREAS, the Certificate of Authority for THE INTEGRAL  
35 INSURANCE COMPANY, to transact the business of insurance in the  
36 State of Alaska was suspended effective August 31, 1992, and  
37 that suspension has been continued to the present.

38 WHEREAS, the 1998 Annual Statement of THE INTEGRAL  
39 INSURANCE COMPANY showed a negative surplus as regards to  
40 policyholders in the amount of \$4,475,631.


1 It is hereby ordered pursuant to the provision of AS  
2 21.09.150(c) that Certificate of Authority No F-1130 issued to  
3 **THE INTEGRAL INSURANCE COMPANY** to transact the business of  
4 insurance in the State of Alaska shall continue to be suspended  
5 for a period of one year unless terminated sooner as permitted  
6 by statute.

7 During the period of suspension, **THE INTEGRAL INSURANCE**  
8 **COMPANY** shall not solicit or write any new or renewal business  
9 in Alaska, but shall file the Annual Statement, pay fees and  
10 any taxes due as provided by AS 21.09.170(b).

11 It is further ordered that Certificate of Authority No.  
12 F-1130 will continue to be held in safekeeping by **THE INTEGRAL**  
13 **INSURANCE COMPANY** until such time as this Order of Suspension  
14 is lifted or is replaced by an Order of Revocation.

15 This order is effective 31st day of August 1999.
