24 WHEREAS, a Certificate of authority to transact the
25 business of insurance in the State of Alaska has been issued
26 to **GREAT REPUBLIC LIFE INSURANCE COMPANY**, domiciled in
Washington.

WHEREAS, the Certificate of Authority for **GREAT
REPUBLIC LIFE INSURANCE COMPANY**, to transact the business of
insurance in the State of Alaska was suspended effective
September 15, 1994 and the suspension has continues to the
present.

WHEREAS, The 1999 1st quarter statement of **GREAT REPUBLIC
LIFE INSURANCE COMPANY** showed a surplus as regards to
policyholders in the amount of \$1,986,342. The Alaska
required minimum capital and surplus per AS 21.09.070 for the
kinds of insurance authorized by the state of domicile for
this insurer is \$2,250,000. This results in an impairment of
\$263,658.

1 It is hereby ordered pursuant to the provision of AS
2 21.09.140(a) that Certificate of Authority No F-1179 issued to
3 **GREAT REPUBLIC LIFE INSURANCE COMPANY** to transact the business
4 of insurance in the State of Alaska shall be suspended for a
5 period of one year unless terminated sooner as permitted by
6 statute.

7 During the period of suspension, **GREAT REPUBLIC LIFE**
8 **INSURANCE COMPANY** shall not solicit or write any new business
9 in Alaska, but shall file the Annual Statement, pay fees and
10 any taxes due as provided by AS 21.09.170(b).

11 It is further ordered that Certificate of Authority No.
12 F-1179 will continue to be held in safekeeping by **GREAT**
13 **REPUBLIC LIFE INSURANCE COMPANY** until such time as this Order
14 of Suspension is lifted or is replaced by an Order of
15 Revocation.

16 This order is effective 15th day of September 1999.
