that Certificate of Authority No F- 631 issued to **RELIANCE NATIONAL INDEMNITY COMPANY** to transact the business of insurance in the State of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall automatically suspend the authority of all its agents to act as agents of **RELIANCE NATIONAL INDEMNITY COMPANY** in this state.

IT IS FURTHER ORDERED, during the period of suspension,


RELIANCE NATIONAL INDEMNITY COMPANY shall not solicit or write any new business in Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).


