1 **WHEREAS**, the Certificate of Authority issued to **NORTHWESTERN**

5 Alaska was suspended on December 28, 1992 and that suspension has been
6 continued to the present.

9 **WHEREAS**, the 2000 Annual Statement of **NORTHWESTERN**
10 **NATIONAL** showed that the company has continued in a runoff status and is not
11 writing any new business.

14 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a)
15 (2) that Certificate of Authority No F- 0652 issued to **NORTHWESTERN**
16 **NATIONAL** to transact the business of insurance in the State of Alaska shall be
17 suspended for a period of one year unless terminated sooner as permitted by
18 statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend
19 the authority of all its agents to act as agents for it in this state.

22 **IT IS FURTHER ORDERED**, that during the period of suspension,
23 **NORTHWESTERN NATIONAL** shall not solicit or write any new business in
24 Alaska, but shall file the Annual Statement, pay fees and any taxes due as
25 provided by AS 21.09.170 (b).
