**INSURANCE COMPANY** was found to be insolvent and placed into liquidation  
by an order of the Circuit Court of Cole County, Missouri on November 30, 1999.

**WHEREAS**, **INTERNATIONAL FINANCIAL SERVICES LIFE**  
**INSURANCE COMPANY** has not filed a financial statement reporting results  
for the years 1999 and 2000. In addition, the company has not paid continuation  
fees due in 2000 and 2001. Both actions are required during the suspension  
period under the provisions of AS 21.09.170(b)

business of insurance in the State of Alaska was suspended effective May 19, 1999, and that suspension has been continued to the present.


**WHEREAS**, AS 21.09.140(a)(2) states that the director shall suspend or revoke an insurer's certificate of authority if the insurer no longer meets the requirements for the authority granted, on account of the insurer becoming impaired or insolvent or otherwise.

**IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140(a)(2) that Certificate of Authority No F-1492 issued to **INTERNATIONAL FINANCIAL SERVICES LIFE INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be revoked. The authority of all persons to act as agents of **INTERNATIONAL FINANCIAL SERVICES LIFE INSURANCE COMPANY** in Alaska shall be revoked.

**IT IS FURTHER ORDERED**, Certificate of Authority No. F-1492 held in safekeeping by **INTERNATIONAL FINANCIAL SERVICES LIFE INSURANCE COMPANY** shall be returned to the Alaska Division of Insurance by June 15, 2001. An Affidavit of Loss shall be filed if the original Certificate of Authority is not available.

This order is effective the 9<sup>th</sup> day of May 2001.
