1 **WHEREAS**, the Certificate of Authority issued to **CENTRAL**
2 **NATIONAL INSURANCE COMPANY OF OMAHA**, to transact the business
3 of insurance in the State of Alaska was suspended effective August 29, 1989, for
4 a period of one year and that suspension continues to the present.

5 **WHEREAS**, AS 21.09140 (a) (3) states that the director shall suspend or
6 revoke an insurer's Certificate of Authority if the insurer's authority to transact
7 insurance is suspended or revoked by its state of domicile.

8 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.150 (c)
9 that Certificate of Authority No F- 0350 issued to **CENTRAL NATIONAL**
10 **INSURANCE COMPANY OF OMAHA** to transact the business of insurance in
11 the State of Alaska shall be suspended for a period of one year unless terminated
12 sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension
13 shall automatically suspend the authority of all its agents to act as agents of
14 **CENTRAL NATIONAL INSURANCE COMPANY OF OMAHA** in this
15 state.


16 **IT IS FURTHER ORDERED**, during the period of suspension,
17 **CENTRAL NATIONAL INSURANCE COMPANY OF OMAHA** shall not
18 solicit or write any new business in Alaska, but shall file the Annual Statement,
19 pay fees and any taxes due as provided by AS 21.09.170(b).

20 **IT IS FURTHER ORDERED** that Certificate of Authority No. F-0350
21 will continue to be held in safekeeping by **CENTRAL NATIONAL**
22 **INSURANCE COMPANY OF OMAHA** until such time as this Order of
