1 **SECURITY LIFE INSURANCE COMPANY.** The company continues under
2 the Order of Supervision to the present time.

3
4 **WHEREAS,** the Certificate of Authority of **AMERICAN FINANCIAL**
5 **SECURITY LIFE INSURANCE COMPANY,** to transact the business of
6 insurance in the State of Alaska was suspended effective September 2, 1992, for a
7 period of one year and that suspension has been continued to the present.

9 **WHEREAS,** the 2001 Annual Statement of **AMERICAN FINANCIAL**
10 **SECURITY LIFE INSURANCE COMPANY** showed that the capital and
11 surplus fails to meet the requirement of AS 21.09.070.

12 **IT IS HEREBY ORDERED,** pursuant to the provision of AS 21.09.150(c)
13 that Certificate of Authority No F- 0693 issued to **AMERICAN FINANCIAL**
14 **SECURITY LIFE INSURANCE COMPANY** to transact the business of
15 insurance in the State of Alaska shall continue to be suspended for a period of one
16 year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160
17 (b), this suspension shall automatically suspend the authority of all its agents to
18 act as agents of **AMERICAN FINANCIAL SECURITY LIFE INSURANCE**
19 **COMPANY** in this state.



21 **IT IS FURTHER ORDERED,** that during the period of suspension,
22 **AMERICAN FINANCIAL SECURITY LIFE INSURANCE COMPANY**
23 shall not solicit or write any new or renewal business in Alaska, but shall file the
24 Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).
