WHEREAS, a Certificate of Authority to transact the business of insurance
in the State of Alaska was issued to **THE HOME INSURANCE COMPANY**
domiciled in the State of New Hampshire.

1 **WHEREAS**, The New Hampshire Department of Insurance on March 27,
2 1997 placed **THE HOME INSURANCE COMPANY** under an Order of
3 Supervision which continues to the present.

6 **WHEREAS**, the Certificate of Authority issued to **THE HOME**
7 **INSURANCE COMPANY** to transact the business of insurance in the State of
8 Alaska was suspended on May 23, 1997 and that suspension continues to the
9 present.

12 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.150 (c)
13 that Certificate of Authority No F- 1034 issued to **THE HOME INSURANCE**
14 **COMPANY** to transact the business of insurance in the State of Alaska shall be
15 suspended for a period of one year unless terminated sooner as permitted by
16 statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend
17 the authority of all its agents to act as agents in this state.

21 **IT IS FURTHER ORDERED**, that during the period of suspension, **THE**
22 **HOME INSURANCE COMPANY** shall not solicit or write any new business in
23 Alaska, but shall file the Annual Statement, pay fees and any taxes due as
24 provided by AS 21.09.170 (b).
