WHEREAS, the Colorado Division of Insurance suspended the Certificate of Authority issued to the **INSURANCE CORPORATION OF NEW YORK** on March 12, 2003 as the company was determined to be in a hazardous financial condition and that Order of Suspension continues to the present.

WHEREAS, INSURANCE CORPORATION OF NEW YORK is in a runoff status and is not writing any new business.

IT IS HEREBY ORDERED, pursuant to the provision of AS 21.09.150 (c) that Certificate of Authority No F- 808 issued to the **INSURANCE CORPORATION OF NEW YORK** to transact the business of insurance in the State of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all its agents to act as agents of the **INSURANCE CORPORATION OF NEW YORK** in this state.

IT IS FURTHER ORDERED, that during the period of suspension, the **INSURANCE CORPORATION OF NEW YORK** shall not solicit or write any new business in Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).


