12 Alaska will expire on October 14, 2004 as there has been no evidence presented
13 that the Certificate of Authority issued to **AMERICAN BONDING COMPANY**
14 has been reinstated and the company is in good standing in the State of Arizona,
15 its state of domicile. AS 21.09.070 (d) provides that if satisfactory evidence of
16 the occurrence of a specific event has not been presented to the director within
17 five years after the date of suspension, the Certificate of Authority shall expire.


