6 **IT IS HEREBY ORDERED**, pursuant to the provision of  
7 AS 21.09.150(c) that Certificate of Authority No. F-8023 issued to **VESTA**  
8 **INSURANCE CORPORATION** to transact the business of insurance in the  
9 State of Alaska shall be suspended until such time as the insurer has returned to  
10 full compliance with Alaska Statutes and all orders issued in its domestic state are  
11 removed resulting in the insurer's return to good standing in its state of domicile.  
12 Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the  
13 authority of all of its agents to act as agents of **VESTA INSURANCE**  
14 **CORPORATION** in this state.

19 **IT IS FURTHER ORDERED**, that during the period of the suspension,  
20 **VESTA INSURANCE CORPORATION** shall not solicit or write any new  
21 business in the State of Alaska but shall file its Annual Statement, pay fees and  
22 any taxes due as provided by AS 21.09.170(b).


