WHEREAS, a Certificate of Authority to transact business of insurance in

suspended on June 20, 2008.

1 **WHEREAS, FREMONT LIFE INSURANCE COMPANY** has failed to pay
2 the 2008 and 2009 continuation fee by the due date as required by AS 21.09.130
3 (b) and AS 21.09.170 (b).

6 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.130
7 (b) that Certificate of Authority No. F-1327, issued to **FREMONT LIFE**
8 **INSURANCE COMPANY** to transact the business of insurance in the State of
9 Alaska continue to be held in suspension until such time as it has returned to full
10 compliance with Alaska Statutes unless terminated sooner as permitted by statute.
11 Pursuant to AS 21.09.160 (b), this suspension shall continue to suspend the
12 authority of all agents to act as agents of **FREMONT LIFE INSURANCE**
13 **COMPANY** in this state.

17 **IT IS FURTHER ORDERED**, that during the period of suspension,
18 **FREMONT LIFE INSURANCE** shall not solicit or write new business in the
19 State of Alaska, but shall file the annual statement, pay fees and any taxes due as
20 provided by AS 21.09.170 (b).

24 **IT IS FURTHER ORDERED**, that Certificate of Authority No. F-1327
25 shall continue to be held in safekeeping by **FREMONT LIFE INSURANCE**
26 **COMPANY** until such time as this order is replaced by an Order of Revocation
