1                   **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140  
2 (a)(3), that Certificate of Authority No. F-1428 issued to **IMERICA LIFE and**  
3 **HEALTH INSURANCE COMPANY** to transact the business of insurance in  
4 the State of Alaska shall be suspended until such time as it has returned to full  
5 compliance with Alaska Statutes unless terminated sooner as permitted by statute.  
6 Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the  
7 authority of all of its agents to act as agents of **IMERICA LIFE and HEALTH**  
8 **INSURANCE COMPANY** in this state.

11                   **IT IS FURTHER ORDERED** that during the period of suspension  
12 **IMERICA LIFE and HEALTH INSURANCE COMPANY** shall not solicit or  
13 write new business in the State of Alaska but shall file the annual statement, pay  
14 fees and any taxes due as provided by AS 21.09.170(b).

16                   **IT IS FURTHER ORDERED**, that Certificate of Authority No. F-1428  
17 will continue to be held in safekeeping by **IMERICA LIFE and HEALTH**  
18 **INSURANCE COMPANY** until such time as this order is replaced by an Order  
19 of Revocation, the Certificate of Authority is surrendered or the Certificate of  
20 Authority expires.
