WHEREAS, LUMBERMENS MUTUAL CASUALTY COMPANY is currently in runoff.

WHEREAS, LUMBERMENS MUTUAL CASUALTY COMPANY's Certificate of Authority has been suspended in the states of Tennessee, Florida and Ohio.

IT IS HEREBY ORDERED, pursuant to the provisions of AS 21.09.140 (a) (2), that Certificate of Authority No. F-253 issued to **LUMBERMENS MUTUAL CASUALTY COMPANY** to transact the business of insurance in the State of Alaska shall be suspended until such time as it has returned to full compliance with Alaska Statutes unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all of its agents to act as agents of **LUMBERMENS MUTUAL CASUALTY COMPANY** in this state.

IT IS FURTHER ORDERED that during this period of suspension, **LUMBERMENS MUTUAL CASUALTY COMPANY** shall continue to file the annual statement and pay fees and any taxes due as provided by AS 21.09.170 (b).


IT IS FURTHER ORDERED that Certificate of Authority No. F-253 will
