ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of
Commerce, Community, and Economic Development (DCCED), State of Alaska, states
the issues on which the accusation is based as follows:

1. On December 29, 2023, **JASON SCOTT TOLAND (TOLAND)**,
domiciled in the State of Alaska applied for his initial Portable Electronics
Limited Producer license requesting Portable Electronics authority with
the Division to conduct insurance business in the State of Alaska.
2. Upon review of the application, **TOLAND** responded negatively to
background questions number 2, indicating no administrative actions to
report to the State of Alaska.

- 1 3. The Producer Database and Attachment Warehouse reflects administrative
2 action was taken against **TOLAND** in the State of California in effect
3 January 30, 2020. **TOLAND** failed to disclose his administrative action
4 to the Division and provided inaccurate information on his application.
5
- 6 4. On January 3, 2024, correspondence was provided to **TOLAND**
7 informing of his failure to respond accurately to a background question
8 regarding administrative actions. The Division provided **TOLAND** the
9 opportunity to voluntarily withdraw the application and provide a new,
10 complete, and accurate application within 30 days. No response was
11 received.

- 13 5. AS 21.27.040(a) states that “(a) Application for a license shall be made to
14 the director upon forms prescribed by the director. As a part of or in
15 connection with the application, the applicant shall furnish information
16 concerning the applicant's identity, personal history, experience, business
17 record, purposes, and other pertinent facts that the director may reasonably
18 require. The applicant shall declare, subject to penalty of denial,
19 nonrenewal, suspension, or revocation of a license issued by the director,
20 that the statements made in or in connection with the application are true,
21 correct, and complete to the best of the applicant's knowledge and
22 belief...”

- 24 6. AS 21.27.020(a) provides: "For the protection of the people of this state,
25 the director may not issue or renew a license except in compliance with
26 this chapter and not issue a license to a person, or to be exercised by a

person, found by the director to be untrustworthy, incompetent, or who has not established to the satisfaction of the director that the person is qualified under this chapter."

7. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an individual license, an applicant or licensee shall (4) be a trustworthy person."

8. Pursuant to AS 21.27.040(a), **TOLAND** provided inaccurate information at the time of application. Based on the above **TOLAND's** Limited Producer license application is hereby DENIED.

ORDER

IT IS HEREBY ORDERED, under the provisions of AS 21.27.040(a) that **JASON SCOTT TOLAND** application for the Limited Producer license application in Alaska under National Producer Number (NPN) # 8475728 is DENIED for supplying inaccurate information on the initial application for licensure.
