The central focus of the business plan for the Mykel's Restaurant at the Soldotna Inn involves catering to out of town tourists, offering them clean, comfortable, and affordable accommodation with all the amenities any traveler would expect and prefer to see in their hotel, including a welcoming environment for the guests to eat and drink.

Mykel's Restaurant will also be serving beers, wines, and spirits as possible.

**Explain how the facility was/will be constructed or improved in accordance with this application.**

This facility is located at 35041 Kenai Spur Highway, Soldotna, Alaska 99669. As such it is ideal for travelers who want a comfortable overnight stay in a clean, comfortable, location conveniently located in beautiful Soldotna area.

**2. Who operates the facility for which a liquor license is being applied?**

Jianfeng Pan, Shiping Wang, and Xin Xu are members of WX, LLC, and operate the facility. Jianfeng, Shiping and Xin and staff are dedicated to serving alcohol in a responsible manner, while providing a fun and friendly environment to our out of state guests.

There are 20 units in the building with 18 of the units being standard hotel rooms (equipped with refrigerators and microwaves)

and then there are two large two-bedroom apartments (with full kitchens) for rent at the Soldotna Inn where the Mykel's Restaurant is located. No, we do not stock alcoholic beverages in the rooms.

**5. Does your establishment include a dining facility?**

Yes. The restaurant located in the Soldotna Inn offers a continental breakfast daily in a breakfast area, and a full service food menu for lunch and dinner Mondays through Sundays in a comfortable setting. We have a lounge that has 6 local beers on tap, and 18 wines by the glass and a premium well. We offer wine tastings for special events and weekly live music.

**6. Are additional amenities available to your guests through your establishment (eg: guided tours or trips, rental equipment for guests, other activities that attract tourists)?**

Yes, we assist guests when they inquire about local recreation by arranging guided sport fishing, and sight-seeing trips such as Fjords and Whale watching tours, through other local businesses. We work with the local Chamber Commerce to provide good tourist related information to guests. The Soldotna Inn will continue to operate the facility as a tourist facility.

In short, all of those things, which are routinely done by businesses in Alaska to encourage tourism, will continue to be done by the operators of the facility.

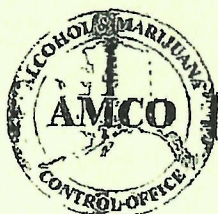
