

Attached is a PDF of the Caterer's Permit Applications for the two events held at the Dena'ina Center on December 3, 2021 and the Notice of Violation received today stating AMCO received the permit application for the Alaska Municipal League on December 5, 2021, two days after the event. The email below, from F&B Manager Marie Purvis with the subject line "Rev 12-3 725 BSB & 12-3 AK Muni. League permit applications" reflects AMCO having received both the applications for caterer's permits on November 23rd for both events held on December 3rd.

The 725 BSB Military Banquet submittal of caterer's permit was originally emailed November 17th and on Nov 23rd additional text was added in response to a request by AMCO for more information. When the revised 725 BSB application was emailed again on November 23rd, the Alaska Municipal League event permit application was also included in the submittal. I respectfully request the Notice of Violation be revised or rescinded. That said, the fact remains we had not received an approved Caterer's Permit for the Alaska Municipal League event by December 3rd and by that time all we could do was send emails/voicemails to AMCO. Moving forward, we will ensure that we have all required approvals in place prior to the execution of the event. Thank you for your time and consideration.
