There is further discussion regarding options – possible new regulations project. Mr. Davis would like the board to table and give him a chance to discuss with local government and get new population numbers. Dana W. states that tabling does not guarantee he will get the license. Diane T. is in favor of tabling and opening a regulation project. Jan H. agrees. Dave K. would like to see history of the regulation project Ms. Oates spoke of. **Doug M. motions to table until two meetings from now, June 28 meeting. Jan H. seconds.
