During the COVID-19 pandemic, our location has adapted to safely provide meals to the support personnel (fuelers, maintainers and crews) for sustainment of air travel infrastructure in Alaska. As the pandemic grinds on, we continue to promote Alaska tourism and customer awareness by featuring all locally-manufactured products to both tourists visiting/departing from Alaska in a safe, hospitable on-premise setting, as well as providing Alaska residents an opportunity to travel with Alaskan-made products from our co-located post-security package store.

We work closely with State of Alaska DOT leasing personnel to ensure alignment of our service operations to safely and responsively meet the needs of the traveling public as well as the support personnel and aircrews. 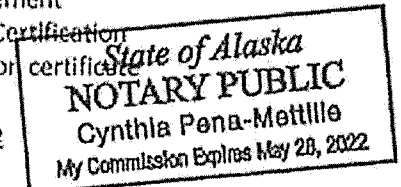
