**Sarah Oates, President and CEO of Alaska CHARR, is in person. I have two brief comments. My first is to welcome Ms. Wilson in her role as Director. My other requirement is regarding the meeting minutes during the last meeting. You'll recall that at the end of the meeting or a discussion during the alcohol mailbox session about infused ice cream and at the conclusion of that conversation you had with Mr. Moser. When he had requested that you open regulation project, that he needed to bring more than just one individuals interest in. I also made a comment that he also needed any legal opinion that stated that there was legal authority for that product to be for infused products to be sold in the States and I don't believe that is clearly captured in these minutes here. **Doug M. motions to adjust the April 12, 2022 meeting minutes to reflect Sarah's testimony. Diane T. seconds. None opposed, motion passes.****

*Stuart Goering advises that all votes should be roll called during a teleconference.*

**Lee Ellis, licensee of Midnight Sun Brewing Company**, is in person, advisory regarding distilled spirits. AK statutes vs. federal. 04.16.100. I would like to address everybody today about the advisory notice that we received in regard to container sizes for distilled spirits. I believe that the first advisory notice was rescinded by the second advisory notice, however there's still problems with the second by three points. The first and foremost thing is that there's no last statute regulations regarding container sizes for distilled spirits, there could be, but there is not. Federal regulations that were quoted in that advisory notice, including us, I believe some part 503 excluded one that basically states that container sizes are in regard to importation and interstate sales. So any sales that occur from within the state of Alaska to the retailer within the city of Alaska are not covered by TTB regulations and requirements container sizes. Another important thing to note is that TTB is actually it has out for public comment right now to completely rescind container sizes. But I think the most important thing is that we, as an industry are concerned, anytime you see an advisory notice or any sort of state action in regard to federal regulations when state doesn't have, or at least under Title 4 any sort of ability to enforce federal regulations. Because, believe me, if the state good and for some federal regulations, we would have some that we would really like to see enforcement doing. Illegal trade practices things that do occur in the state, so we would just ask that in support consider his (Sassan Mossanen) position and also please reconsider how we communicate, considerations with regards to relations. And again, please be aware that and subpar level one it stays at this is only in reference to interstate. So, if an out of state distiller would like this, so package in Alaska than it does have to comply with federal regulations were as many factors within the state of you know, and that is just for reference. So as being, it would probably know anytime you want to export your spirit of that label. However, you are not required to get federal approval of labels for beer that is sold only within the state. I seem to recall.

**Sassan Mossanen, licensee of Denali Brewing**, on Zoom, advisory regarding distilled spirits. I would like to congratulate Ms. Wilson on her new appointment and actually thank her and staff for actually engaging me at a pretty high level with trying to kind of determine exactly what's at the root of this issue. So we've had somewhat I felt like a very productive meeting, so thanks to staff and the board for giving me the time. I understand that this is being discussed during public comment but maybe if I could request something for consideration is that if the Board is going to have a further agenda item in which they're going to make a determination on this, to give me an opportunity to kind of revisit this at that segment if this issue isn't laid to rest. Right now, I feel like just because of the direct implications that it has to our license and just kind of the expertise that I have in the area, I could potentially answer questions that the staff might have with regard to this. So with kind of stated, I apologize if there's a little bit of redundancy with what we already spoke about, but I think at the root here is state versus the federal regulations. And just acknowledging that there are multiple areas in which the feds have CFR and regulations with regard to a whole host of area everything from tribal sovereignty, to hunting and fishing, natural resource development and cannabis and, most importantly, with regard to alcohol, where the state either chooses to take a different path or does have mirroring language to federal statute. And so when you're trying to determine, you know, is this an issue or not? We know that the feds, for example, do not permit. You know the cultivation trail of cannabis, but the state of Alaska has chosen to create a regulatory agency that governs this as an industry and collects revenue and we even have examples of this within the alcohol industry in which the Federal Government has fair trade practices that have prohibitions against inducement and exclusionary practices. All of which are very important, but the state currently has no regulations to match that, and so there has been no enforcement of those really important issues. Fortunately, as a result of the Title 4 rewrite and SB9, these issues with regard to the alcohol industry when identified. Through the stakeholders group that these fair trade practices should get enforced, so the point being there's multiple areas in which federal versus state regulation don't coincide and I'm not aware of any situations in which a state regulatory agency is going out of his way to enforce federal regulations that have no mirroring language within its state regulations. I'm also aware that the Board has asked the staff to reach out to TTB and ask them if this practice of filling ready to drink cocktails is permissible in the Federal CFR. And what I would argue, is that if you ask the wrong

question, you will get the wrong answer and so as Lee (Ellis) has mentioned with regard to the federal CFR and there's an additional layer to expand upon what Lee already stated, is that those CFR are intended to govern sales to individual and that's not what we're doing.

Our distillery is not selling these kegs to individuals, they're being sold to other license holders and so it's really important that when the question is being asked that in regard to what the practice that we're doing and so that's just another consideration is that the federal government is concerned with those packages being sold to individuals, as opposed to being sold to bars or beverage dispensary license. And so you know the question stands with regard to that you know why does AMCO even concern itself with the federal CFR is there. Kind of a reason to do that, and so the question is, if the State feels that this is an issue that it wants to endeavor, then how come it wasn't addressed in the SB9 Title 4 rewrite? There was 10s of thousands of hours spent trying to develop a new title for which could govern us for generations to come and this issue with regard to container size was not addressed so the point being, from health and social services from the public safety from every aspect that the Department of Commerce is there to regulate there's no point in the state going out of its way. This reminds me of a little bit this particular situation is when the state was looking at multiple manufacturer tasting room limitations that this came to the table and AMCO and the board decided to view this and create a project. Determine how they want to handle it. And if memory serves me correct, it was the largest public comment in opposition to that regulatory research project, there was. Over 1000 comments in opposition to that there was not one single vote of or comment made to support the increase or reducing the limits on multiple manufacturer tasting room. And I would argue that this project will have the same exact type of response. So if this goes out to public comment, you will see that the public will come out and say why are you doing this, there's no purpose for restricting this type of activity and it really becomes relevant when you put it in the backdrop of the fact that the feds and TTB, just as Lee had mentioned, opened up a public comment period to see if there's an interest in abandoning this container size limitations all together. And so you even have the feds questioning whether this is if there's any merit or point in this and so you know I would suggest that if the feds have no appetite for it there's no current statute or regulation in the state of Alaska that is prohibiting this activity, then, why would we go out and do this?

There's been no, you know public outcry, there's been no safety issue and, in fact, in my conversations with AMCO staff, it became apparent that this came to their attention via two phone calls that were made to the AMCO staff. One was made from one of our staff members, who was a brand ambassador going out into the field and having the competition accuse us of doing things that were illegal and she felt threatened by their action, to the point where she took it upon herself to call AMCO and try to get clarity on it. And no surprise to all of us, the other call was actually coming from the competition trying to bring this to close attention via the form of a question. And so it makes me wonder does AMCO want to become the agency that regulates competition within the state and by engaging in this and creating restrictive language when you get a competitive natured phone call it's not the type of use that enforcement, I believe, wants to engage in, and so I just encourage us to try to bring closure to this issue.

And my kind of final request is the last two advisory notices that have come out with regards to this issue have admittedly been confusing and if the board sees fit to bring this topic to close, I would ask to create clarity for the industry by shading in an advisory notice that the state has no opposition of ready to drink cocktails being packaged in kegs and being sold to the appropriate license holders, so if the language in the future advisory notice can paint a very clear picture, we would be grateful because that's what we need, we need regulatory clarity and you know respectfully those last two advisory notices seem slightly confusing, at best, so thank you for that the time to speak to this.

**James Hoelscher, present on Zoom**, speaks to the issue and mentions it is also addressed in the Enforcement Report.

Doug M. requests staff to forward all advisories to the board members. Dana W. states that it is not the board's jurisdiction over federal laws. Further discussion between the board members, Director and industry members. **Doug M. motion to open a regulation project to directly reference ready to drink (RTD) cocktails in keg form sold from a distillery to another licensed establishment. Diane T. seconds.** Dave K. doesn't believe this is an issue for a regulation project. Director Wilson suggests a working group and bring an advisory back to the board and withdraw the current advisory. Doug M. would like both issues (sold to consumers and growler bars) to be in the working group. **Doug M. removes his motion. Diane T. seconds. Doug M. motions to open a working group with industry. Diane T. seconds. None opposed, motion passes.**

**Bailey Lande, Pedal Anchorage** and present on Zoom, Diane T. asks if they are selling alcohol? Bailey answers, no. Are people bringing alcohol themselves? Yes, beer and wine. Doug M. asks if she feels that AMCO enforcement singled them out. Bailey answers, yes. Director Wilson states that there have been calls to the office, not just enforcement. The Municipality of Anchorage approved their business model and issued the proper permits. Dana W. advises Ms. Lande that they are concerned that Pedal Anchorage is providing a "place" – more research is needed. Doug M. is concerned about signaling her out – he is comfortable with letting her continue while AMCO conducts further research. Sarah Oates, of Alaska CHARR, doesn't have an official position. Whatever the decision, it must be done consistently for everyone with a similar business, do not single out. State wide board – other communities would be interested. No server education. James speaks/clarifies. Doug and Dana are having difficulty coming to a decision – conflicted by the requirements in Title 4. They do not think they can make a decision at this time. Diane T. says they are providing glassware, coozies, which is prohibited in Title 4. Bailey Lande states they were unaware and says they will not do that. **Dana W. asks for more analysis by staff how AMCO has allowed party buses/limos. Dana W. would like this to be put on the agenda for the September meeting with additional information.** Director Wilson suggests if they have Ms. Lande stop operations, then AMCO needs to enforce equally with other similar businesses.
