MEMORANDUM

Requested action: City of Nome requests special conditions placed on license reinstatement and renewal.

Statutory and Regulatory Authority: AS 04.11.480(c) "A local governing body may recommend that a license be issued, renewed, relocated, or transferred with conditions. The board shall consider recommended conditions and testimony received at a hearing conducted under AS 04.11.510(b)(2) or (4) when it considers the application or continued operation, and the recommended conditions and the record of the hearing conducted under AS 04.11.510(b)(2) or (4) shall be kept as part of the board's permanent record of its review. If the local governing body recommends conditions, the board shall impose the recommended conditions unless the board finds that the recommended conditions are arbitrary, capricious, or unreasonable. If a condition recommended by a local governing body is imposed on a licensee, the local governing body shall assume responsibility for monitoring compliance with the condition, except as otherwise provided by the board."

AS 04.11.470: "A person may object to an application for issuance, renewal, transfer of location, or transfer to another person of a license, or for issuance of a permit, by serving upon the applicant and the board the reasons for the objection. The board shall consider the objections and testimony received at a hearing conducted under AS 04.11.510(b)(2) when it considers the application. An objection and the record of a hearing conducted under AS 04.11.510(b)(2) shall be retained as

part of the board's permanent record of its review of the application."

AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.540: "...If a complete application for renewal has not been filed by February 28 or the required fees and the penalty fees have not been paid by that date, the license expires at 12:00 midnight February 28."

3 AAC 304.160(f): "The board will deny a request for reinstatement submitted under (e) of this section if (1) the license became available in accordance with 3 AAC 304.100(2) and was issued to a different applicant, unless the limit of licenses under AS 04.11.400 has not been reached; or (2) the board finds that the failure to timely file or pay was caused by (A) the licensee's failure to notify the board of a change of the licensee's mailing address; (B) a transfer of ownership of the business for which the license was issued without written approval of the board in violation of AS 04.11.040; (C) a lease of the licensed business to another person in violation of AS 04.11.450(c); or (D) any other action of the licensee whether active or tacit that the board finds constitutes a failure to lawfully operate the business for which the license was issued."

Staff Rec.: Review the City of Nome's request to place special conditions on renewal of license #903 and hold a hearing. Evaluate the reinstatement request in accordance with 3 AAC 304.160(f).

Background: At the April 12, 2022 meeting, the reinstatement and renewal for this license was approved with delegation. Due to the board approval and the fact our office did not receive a timely response from the local governing body, the renewed license was issued to the licensee on May 20, 2022.

During the 2022/2023 licensing period, a renewal application was not submitted by the February 28, 2022 deadline. A warning letter was mailed and emailed to the licensee on February 07, 2022 and the expiration and cessation of operations letter was mailed and emailed on March 4, 2022. The licensee has submitted a request for reinstatement, paid all required fees and the renewal application was deemed complete on March 18, 2022.

The reinstatement and renewal was deemed complete by AMCO staff and notices were sent out to the City of Nome on March 18, 2022. Per AS 04.11.480 a local governing body may protest the issuance, renewal, relocation, or transfer to another person by sending the ABC Board and the applicant a protest and the reasons for the protest within 60 days of the receipt from the application completion notice. The 60-day deadline for the City to respond was May 17, 2022. AMCO received a letter from the City requesting conditions on the license on June 3, 2022, envelope was postmarked May 27, 2022. The letter itself was written on April 25, 2022 and states it was sent via regular mail and email, however staff does not show a record of receiving the email.

Dear Mr. Klinkhart:

This letter constitutes the City of Nome's recommendation that the above-referenced license be renewed subject to the following conditions:

- 1. Licensee shall employ and have on site (including the outside area immediately adjacent to 415 Bering Street) security personnel (at least one person on duty during all operating hours).
- 2. Licensee shall not sell alcoholic beverages (other than beer or wine) in containers larger than .75 liter.
 - 3. Licensee shall limit sales of alcoholic beverages to a single sale per person per day.
- 4. Licensee shall not sell that single person more than one container of alcoholic beverages (other than beer or wine) per sale.
- 5. Licensee shall work with other package stores in the community to restrict sales to runners providing liquor to individuals barred from the purchase of alcohol by other package good stores.

These recommendations are made pursuant to AS 04.11.480(c). The basis for the recommendations is the high frequency of police calls to this address and the adjoining park at Old Saint Joe's. In just three months fifteen calls alone have come from Hanson's alone.

The City believes that limits on the quantities and frequency of alcohol purchases as well as the presence of on-site security is a reasonable condition to impose on the licensee in the name of public safety and the general welfare of Nome residents.

Please take these recommendations under consideration and advise me when the public hearing is scheduled. In advance, thank you for your attention to this request.




The transfer of the license in question to the company from the prior license holder was completed in late September/early October 2021, at approximately the time renewal notices are sent to license holders. Neither the company, nor our local licensing partner in Juneau received the renewal paperwork, presumably because it was sent to the former license holder who did not forward the information to the company. Prior to this, the company had never failed to renew its license in a timely manner.

It is also important to note that Carr-Gottstein is a part of the Albertsons Companies, Inc. family. Albertsons and its various brands currently hold twenty-six liquor licenses in Alaska, twenty-five of which were renewed in a timely manner. The fact all but one of these licenses was properly renewed shows that the company had every intention of renewing this license but failed to do so because it was not aware a renewal was due for this newly transferred license.
