Director Klinkhart summarizes his report and announces his resignation. Dana W. introduces and reads into the record a resolution of a commendation for Director Klinkhart. **Doug M. motions to approve. Diane T. seconds. None opposed, motion passes.**

9:28 am: Chief Hoelscher presents his report. The Chief brings up the subject of tap trucks being operated as a bottle club. He would love to hear the Board's opinion. Diane T. discusses the tap trucks and mobile trolleys that sell, serve alcohol operating in other states – would they need to obtain a catering permit from AMCO. The Chief says yes – the owner of the truck could lease the vehicle to a licensee who would then in turn apply for a permit.

Dana W. points out that leasing the equipment, not the alcohol, would not be a violation of Title IV, the issue is when it becomes when they act like a bottle club. (audio issues) There is further discussion by the board. Are these vehicles that provide glassware/taps/staff at a public event a permanent "place" or a "premises"? Dana W. believes this situation would violate the bottle club statute (AS 04.16.090).

The Chief believes even renting the vehicle for a private event would be a violation. He states that AAG Wilson told him she agreed with Enforcement but it would depend on the board's definition of a "place" or a "premises". The issue is when the owner of the vehicle is providing equipment and glassware for the customer's kegs and offers to tap the kegs and serve the alcohol for the customer. It straddles the line of a non-licensee acting in the capacity of a licensee. The Chief states that at the time the bottle club statute was written, mobile bars or mobile kegs were not anticipated. Trends are out-pacing our laws. The only way we can enforce this is that the board determines that these vehicles that are being used for this purpose are either considered a "place" or a "premises".

Dave K. asks if this is akin to party buses providing alcohol when they are not licensed to sell and distribute alcohol. Chief Hoelscher states that is correct, it would technically be a violation of AS 04.11.090.

Dana W. states that if a non-licensee either provides a fixed location, or staff/servers to assist with the dispensing or consumption of alcohol, or stocks or otherwise provides alcohol to these events would be a violation of the bottle club statute. The board members agree. Chief Hoelscher agrees. (audio/chat issues on Zoom) Dana then asks Richard Moses if the board has authority to craft guidance to licensees and staff. Richard says, yes. There is some back and forth between Diane T. and Chief Hoelscher. He reiterates that a licensee (BDL/REPL) could lease these tap trucks if they get a permit for an event off their premises. Doug M. motions to provide formal guidance that a premises would be considered in the event an entity provides a fixed location or provides servers for staff to assist in the serving or in the consumption or stocks alcohol or otherwise provides beer, spirits or wine for an event. Dave K. seconds. None opposed, motion passes.

Dana W. mentions the issue of distilled spirits being repackaged in package stores in growlers/kegs. He asks Chief Hoelscher if violations were issued. It was a first-time offense and Enforcement issued advisory notices to the licensees. However due to some follow-up information that the violations are still occurring, there is an ongoing investigation. Dana W. asks for the federal regulation or guidance for the kegs and he is anticipating a change in the future – the Chief agrees. Dana W. requests that the Chief will have that information for next board meeting. Federal authorized size is 1.8 liters.

Sarah Oates, as former AMCO employee and not taking any position on the issue, reads AS 04.11.360(4) into the record. Debt from other entities (even if same owner) may not be considered by the board. Mr. Alexander says he never served alcohol at the south location that Ms. Boutin is referencing. The other creditor, Ms. Johnson, and/or her counsel is not present.

Doug M. motions to approve the transfer of ownership for licenses 4531 and 4551 with delegation and that delegation includes Trina Johnson's debt be satisfied. Jan H. is having some audio issues. There is no second. After further discussion, Diane T. seconds. None opposed, motion passes.

Transfer of location discussion. Mr. Alexander provides a history and discusses his challenges with the Downtown Community Council and Assembly of Anchorage. He speaks about the updated diagram by moving the main entrance. Director Klinkhart speaks about safety concerns that the east door would likely still be considered an entrance/exit and it depends on the fire marshal. Mr. Alexander is confident it can be done and the east door would not be an entrance. He is agreeable to an abeyance period to allow him time to address and solve the door/distance issue.

Sean Halloran, counsel for the Municipality of Anchorage, is present in person. The land use permitting process is not complete and the Municipality continue to protest the transfers until the process is complete. They will be presented at the Assembly meeting this evening, but may not be completed tonight. The Municipality is only protesting to the location transfer. There is a discussion about the distance from the premises doors to the school grounds.

Mandy Honest with the Municipal Clerk's Office Business License Official, is present on Zoom, and speaks about the multiple special assembly meeting/public hearing that was held last month and an explanation of the city's protest.

Mr. Halloran states the only definition of "school grounds" for purposes of liquor licenses in Alaska statute is found in criminal code AS 11.71.900(29) which says, "school grounds" means a building, structure, athletic playing field, playground, parking area, or land contained within the real property boundary line of a public or private preschool, elementary, or secondary school. He does not know who owns the parking lot or the degree to which the parking lot is used in relation to the school or if it is considered part of the school grounds. There was public testimony that the school does utilize the lot.

Steve Rader, General Manager for the Hilton is present on Zoom, states he is concerned that Mr. Alexander's nightclub would negatively impact nearby businesses, public safety and loud noise, crowds at bar break. He states he has discussed his concerns with Mr. Alexander. Mr. Rader has additional concerns if the entrance to the nightclub is moved to the E Street side of the building which would be approximately 75 feet directly across from the Hilton's main entrance. He states this will create additional challenges that he is not sure there are solutions for.

Doug Farris, representative for the Downtown Community Council is present in person, speaks about the entrances and provides a map with surrounding businesses as well as a short video to show the board about the negative impacts of nightclubs downtown. There is a discussion about

the Municipality's protests. Mr. Farris states the community council isn't concerned about what happens inside the club, the problem is the crowds massing outside which Mr. Alexander cannot control no matter how good of an operator he is. He does say the Downtown Community Council would be open to conditions placed on the license, such as limited hours.

Buzz Rohlfing, licensee and property owner downtown for 20+ years, is present in person. He has seen all the troubled bars/nightclubs (Rumrunners, Millennium, Brown Bag, etc.) come and go and all those owners would promise they would work with him (nearby businesses/residents). But there were many late nights (every weekend) of loud noise, possible drug use in vehicles, fights, shootings, police activity, he would request the music gets turned down and was threatened with physical harm. He has had his car damaged the next day after some confrontations. Mr. Alexander is a good guy and operator but was surprised at Mr. Alexander's statement which was, "When they get outside of the LED club, it's not my problem." So, it isn't his problem, but it's the problem of the surrounding residents and guests at the nearby hotels (nearly 2,000 people in summer).

Kristin Anderson, resident and property owner downtown, is present on Zoom to testify. She says having a nightclub open from 11pm to 3am seven days a week is not a good fit for the neighborhood. It is a quiet neighborhood with a notably high concentration of hotels, motels airbnb and residential properties. Many residents do not have air conditioning and sleep with open windows during the warm weather and having potentially hundreds of people coming and going to a club right outside our windows would have real effects on daily life. In addition to likely causing problems for residents, local businesses, convention center attendees, school children and their parents this would negatively impact our existing tourism. It would likely harm the city's revenue, the 12% bed tax is a huge source of money for Anchorage, with an average of \$26 million dollars per year since 2014. We don't need vacancies in our hotels or motels and/or air-bnbs. Also, if your neighborhood is no longer inviting to guests the property values decrease, not only would that be bad news for property owners, but lower property values means lower tax revenue for the city. A nightclub in this location would not be in the public's best interest.

Terri Roissy, General Manager with the Historic Anchorage Hotel is present in person to testify. They are against have the club open across the street. She has been with the hotel for 18 years and is familiar with the problems stemming from the previous clubs in the area. The 26-room hotel does not have air conditioning and window go get opened in summer. She has had customers complain and cut their stay short. They have to get up at six o'clock in the morning to get on a train to go to Denali or Seward and they do not go or they're going but they're going to sleep on the train, because the bar break at 3am is allowed in the neighborhood and it's not only on E Street. It is 4th Avenue and 3rd Avenue as well. Currently the hotel is the number one hotel in downtown on Tripadvisor, number seven overall out of all of Tripadvisor. In the past, when there was a club on the corner, the reviews of the hotel were bad. The bars and restaurants that close at 11pm are great neighbors with no problems. This nightclub will hurt the revenue that they are finally going to make after two years of the pandemic. Their guests park in the same parking lot that is adjacent to the proposed premises which means the quests will need to walk around the nightclub to get to and from the hotel. She addresses Mr. Alexander's criminal case which has not been closed. They are opposed to the transfer because it violates long established Alaska state statutes and Anchorage municipal codes that are in place to create healthy and safe businesses and residential communities, the transfer of the location of LED materially changes the environmental conditions in which the businesses would create a significant impact on the use and enjoyment of adjacent properties and the property owner's occupants.

Mr. Alexander provides a rebuttal. Mr. Rohlfing's comment that "once they are outside he doesn't care" contradicts three years of testimony and pictures of Mr. Alexander picking up trash me and his staff and shooing people away at bar break hour. He never said that he doesn't care and wants to clarify that. He has been here before in 2013 and he gets it. When someone doesn't want something, they try to find all they can to smear someone and he thinks it is a low blow. However, she is somewhat right. He didn't appreciate Ms. Roissy bringing up the criminal case when it was done in self-defense. They mentioned the E street entrance but they never mentioned the 3rd street entrance. Mr. Alexander states, "This is the part where I find this whole thing discriminating." There are going to be issues with nightclubs. He claims the Downtown Community Council is treating his business differently than the other trouble bars in the downtown area due to race – they do not protest/object those other bars where are safety issues. He points out there are no minority owned bars downtown any longer and the ones that were previously owned by people of color are no longer there. It makes him angry and it's not fair.

There is a procedural discussion between counsel and the board members.

He walked into a very challenging position on a temporary basis and then went through the pandemic with most of you, and had me freaking out on him numerous times about media, to do stuff and things across the board and while we haven't always agreed on everything, he's always listened to the industry's perspective, and I really appreciate that the communication between industry and the regulatory body continues to improve under leadership that has changed. Thank you to the board for your contribution for that as well. As the board, as you know, it is your duty to direct the director on priorities that kind of thing and under Director Klinkhart's leadership, there have been some significant steps taken toward change, making some changes that would help not only the industry but also again the relationship between industry and regulatory body. He has really wanted to make sure that the local government specialist, which was originally intended to be a proactive education position, we truly get to be a proactive education position, I know because I wrote that position description. So I would hope that whoever comes into this role, you will direct them to continue some of the things that Director Klinkhart has started, including that community policing does the work. You've got a really great enforcement team, a lot of really good investigators and, from my perspective, he has been working hard to empower them to use all of their tools. The relationship between unfortunately the industry hasn't always been great because a lot of the education that occurred is they're thrown the Red Book and said, "figure it out, good luck, you're expected to comply, and if you screw up you're going to get a notice of violation that's going to be a permanent marker on your license file" which has repercussions with your insurance company. And for a long time, up until recently, an accompanying mismatch and in under Director Klinkhart's leadership is you know he cares about having investigators be able to have an open line of communication with licensees where they aren't scared to call up an investigator and be like, "hey I'm not really sure what I'm supposed to be doing here", or if, "I'm not in compliance, can you let me come into compliance right now". I think that exists a lot where the industry doesn't know whether they're compliant or not on certain things and so they are just winging it, and so I hope that you will direct the new director to continue to work on community policing. His work on an online licensing database will be life changing for his team, especially for the industry, you have been through many renewals and currently as you were talking and that process, and it is not the most streamlined. And then the last thing is the Title 4 rewrite - obviously have set a goal line goes through it's going to be a massive amount of regulation projects, I would highly recommend that you form a working group or a committee that is made up of at least the members of the steering committee for the rewrite as well as Recover Alaska and the Brewer's Guild. Because we have a lot about long standing knowledge of a lot of these statues and would be able to help with drafting regulations on the front end that hopefully won't need lots of tweaks or me sending you requests to edit this and delete that or you know object to something else. I think it will help make that process smoother so that is really all that I have to say and we will really miss Director Klinkhart. I'm really sad, the industry is really sad, but we look forward to bringing on a new one and working with that person, thank you.

7:35 pm: Chuck Fagerstrom, from Nome, present on Zoom: I had a difficult time getting unmuted. I'm just happy that the Board is coming to Nome and that you're willing to meet with the Community of Nome on the alcohol situation here but on March 22 of this year, I sent an email question to the alcohol licensing group and the question is, a community such as Nome, which is a first class city have a city owned package store by eliminating all private owned and operated package stores licenses in Nome, but still allow every dispensary licenses and bars that are privately owned and operated to operate under their own license. I don't think they (city officials) were able to find a happy way to do that. There's a lot of things that have to occur, but at least it sounded like the mayor considered it, so you might want to circle back or maybe we can have a discussion where

there is no to see what the specific issues were, why they couldn't do that. Okay, and that's, the reason I cut in into your conversations, is that I wanted to show this out before you folks came up to Nome so that you would be aware of one of these questions to allow the city to have their own package store, but still allow private operators for bars and restaurants to do their own thing. Okay, much appreciated and thank you.
