This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 5-11-21, Dept. of Labor had notified AMCO Enforcement they had conducted an inspection at your establishment and located 5 minors who did not have work permits. Of the 5, four were hired in 2020, 1 was hired in 2021. One of the 2020 hires no longer works at the establishment. After the inspection, you did complete the necessary paperwork for the four remaining minors. However, the violation has been occurring for over a year at the longest hire. Your records indicate in that you were also given a notice of violation for the same offense Sept. 17, 2008, Case #08-1197. Ownership of the organization has not changed from the first violation to the current.

Your attention is directed to AS 0416.049(a) & (c)(1)(2) & (3): Access of persons under the age of 21 to licensed premises, AS 04.16.052(2), 3AAC 304.795: Suspension or revocation of designation, AS 04.16.150: Licensee responsible for violations and AS 04.21.030: Responsibility of licensees, agents and employees

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.

3 AAC 304.525 (B) provides that upon receipt of a Notice of Violation, a licensee may request to appear before the Director and be heard regarding the Notice of Violation. A Licensee shall respond, either orally or in writing, to the Notice.

In response to this Notice of Violation, regarding not having the proper permits for underage employees, we have taken the following steps as to prevent this from occurring again:


As stated in Notice, we have gone through our files, and have updated any current employment files (Underage), so that all files/permits are current.

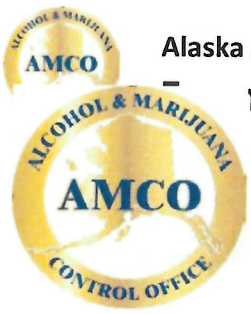

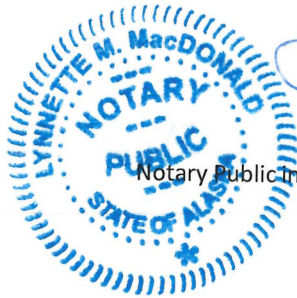

Good afternoon,

I'm contacting you to let you know that after reviewing your license renewal applications, I have found that they are currently incomplete. I have called you on three separate occasions as well as emailed you once previously.

On license #4157 DBA: Downtown Bear Paw Bar & Grill, the following needs to be corrected:

- Page 2, section 5 there are two boxes checked for the 2022 year (only one box should be selected). I need to know if the license was operated for more than 240 hours throughout the 2022 year.

On license #4279 DBA: Bear Paw Bar & Grill, the following needs to be corrected:

- Page 2, section 5 there are two boxes checked for the 2022 year (only one box should be selected). I need to know if the license was operated for more than 240 hours throughout the 2022 year.
- Page 2, section 6 is incorrect, the box indicating that there were no violations for 2021 was checked. This is incorrect, there was a Notice of Violation in 2021 (5/24/2021).

Since these discrepancies are just a matter of checking the correct box, this can be a simple fix. If you give me permission to check the appropriate box via your response through either email or phone, we can then proceed on with the renewal process for your licenses. Please keep in mind that the next board meeting is August 22, 2023. We would need to have the issues addressed above resolved before the close of the day on August 4, 2023 in order for these licenses to be considered by the board on the August 22, 2023 meeting.
