

I have been the President of Bolshio Misha Inc for the past 10 years, a company that owns and manages commercial properties within the Mat-Susitna Valley. Throughout this tenure, I have served many Alaskan businesses and leased space to them ensuring success in their many entrepreneurial endeavors. Six years ago, I discovered Meier Lake and purchased the property of Meier Lake from the Episcopalian Diocese of Alaska, taking a dilapidated summer camp and transforming it into a space in which both local Alaskans and tourists love to spend their time.

Renovating the property was a passion project for me.
