This statement is being submitted to the Alaska Alcoholic Beverage Control Board ("Board") as a part of our renewal application demonstrating to the Board our qualifications for our liquor license to be renewed. The Millennium Alaskan Hotel is a tourist destination in Anchorage, AK which was built along the eastern shore of Lake Spenard and amidst many outdoor attractions in this area of Alaska. It is just one minute from the Anchorage International Airport and is ideally situated for tourists. The hotel has its own float plane dock to take tourist on excursion flights seeing Alaska's great outdoors from the air including Mt. McKinley and the Chugach Mountains. It is also near such tourist sites as the Alaska Zoo, The Alaska Aviation Heritage Museum, the Anchorage Museum of History and Art, the Tony Knowles Coastal Trail, the Earthquake Park, the Anchorage Coastal Wildlife Refuge, and the Native Heritage Center. It is a popular destination for tourists interested in seeing local attractions and/or interested in sporting activities as well as family vacations. The hotel has a total of 248 guest rooms, including 3 suites, and 7 meeting rooms which is attractive to business tourists looking for an ideal scenic location in Alaska to host business meetings accommodating up to 300 attendees with extensive audio/video equipment and technicians. The hotel has 3 restaurant areas which includes the Flying Machine Restaurant open daily for breakfast, lunch, and dinner; the Fancy Moose Lounge offering casual dining open for lunch and dinner; and the Lakeside Patio which is

outdoor dining and opened seasonally. In addition it offers conference and banquet meal service to large groups who dine together.

Additional amenities offered by our hotel include complimentary shuttle service to and from the airport; complementary shuttle service to and from downtown areas; scheduling tours and trips for hotel guests to points of interest in the area, including airplane excursion flights leaving from the hotel's float plane dock; and state of the art exercise equipment for quests. Our hotel quests can stay linked to their businesses while enjoying their stay with business connection services including high speed internet and a business center.

This property advertises in many different ways to promote its resort as a tourist destination point around the world. The hotel partners closely with the Alaska Travel Industry Association and the State of Alaska Tourism Marketing Arm. In addition the property advertises in the Alaska State Vacation Planner and in the local Alaska Visitors Bureau vacation planner. As part of the Millennium Properties it partners with the Millennium Corporate Office through website advertising and search engine optimization.

In 2012 the property hosted 280 conference meetings and events with a total of 34,899 separate food service events. In 2013 the hotel has projected an increase in tourists using the property advertising and client satisfaction.
