This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

**Note: This is not an accusation or a criminal complaint.**

On 7-27-21, an inspection was conducted at your establishment. Server Brandi Johnson and Licensee Paula Monsen were asked to provide proof of server education. Neither could provide proof of current server education. However, prior to Inv. Hamilton's departure, Ms.. Johnson had challenged the CHARR TAP course and passed.

Your attention is directed to AS 04.21.025: A server education course, AS 04.16.150: Licensee responsible for violation and AS 04.21.030: Responsibility of licensee, agents, and employees.

Ensure you provide this office with proof of attending an approved server education course prior to selling alcoholic beverages.
