Application Statistics

We include a summary of applications currently in AK-ACCIS as well as paper submissions. Please know that many of these applications are already before you for review in this meeting as described in Tab 10. Following this board meeting, the licensing team will be focusing on addressing the transfer applications in paper form, which were not addressed in the past months, because of all the work that needed to be completed for the Title 4 Rewrite implementation and because we expected a buildout from AK-ACCIS to incorporate this application type. That buildout is still not complete.

Nevertheless, whether in paper or electronic form., transfers will be our focus following this Board meeting. The 2024-2025 renewals will also be a priority, but, as we get through this backlog, we expect to be providing many temporary extensions. As mentioned in the Director's report, the full next year will be bumpy when it comes to bringing everything into the electronic setting. We do believe the long-term success will be worth it.
