Form AB-41: Common Carrier Approval Registration

Why is this form needed?

Registration Fee: \$1,250

Per AS 04.09.750, a common carrier may not transport or deliver alcoholic beverages to a person in the state unless the ABC board has approved the common carrier.

In section two (2) of this form, a detailed diagram (or description) of the secure storage location where alcohol will be held (both prior to and after transport) is required. Your diagram (or description) must include dimensions and must show all entrances and boundaries of the premises and areas of storage.

In section three (3) of this form, you must describe how the carrier will verify age and obtain a signature of the recipient. You must also state where records of shipments of alcoholic beverages will be held and made available for inspection and audit by AMCO Enforcement.

Per AS 04.09.750(c) delivering alcoholic beverages to a person in the state shall ensure that the package containing alcoholic beverages is delivered directly to a person who:

- (1) Presents identification and acceptable proof of age under AS 04.21.050 showing that the person is 21 years of age or older; and
- (2) Provides a signature acknowledging that the person received the package.

Per AS 04.09.750(d) an approved common carrier shall make records of shipments of alcoholic beverages to persons in the state available for inspection and audit by the board.

Section 3 – Description of Control Measures

Carrier must clearly indicate how the provisions of AS 04.09.750 (c)(1) and (2) will be met

Accepting ID: AS 04.09.750(c)(1)	Customer service agent must check for valid identification for every customer picking up shipments containing alcohol. The customer must be at least 21 years of age on the day of pickup. The following photo ID may be accepted as proof of age: 1) a valid driver's license from any state 2) a valid state-issued (non-driver) ID from any state, and 4) a valid ID card issued by the federal government [e.g., passport, permanent resident card ("green card")]. A valid ID must contain the date of birth and a photograph. The customer service agent must verify that the photo matches the customer. An expired ID is not considered valid and must not be accepted. If the ID is not valid, the customer service agent will not hand the freight over to the customer.	Obtaining signature: AS 04.09.750(c)(2)	After the accepted photo ID is checked and approved, the receiving customer must sign the provided shipment consignment note, where it states, "Received in good condition by:". The signed consignment note will be retained for one year.
