\_\_\_ **Level 1: Sight and Sound Supervision:** This requires that a supervisor be present at all times with the child. The supervisor must maintain the child both within hearing and sight.

\_\_\_ **Level 2: Monitored Parenting Time:** This requires that the supervisor remain at the location of the visit at all times with the child nearby. The child and parent may be out of the supervisor's range of sight and hearing for brief periods of time.

\_\_\_ **Level 3: Monitored Location:** This requires that the supervisor check in on the child and parent periodically during a visit at a set location. Monitored visits are used when there continue to be safety concerns, but the safety concerns are controlled by the environment and by the periodic observation of the parenting time supervisor.

\_\_\_ **Level 4: Monitored Exchanges:** This requires that the supervisor be present only for times that the child is being exchanged.

**ADDITIONAL PROVISIONS**

- The supervised parent may not make derogatory comments about the child or the child’s immediate family or caretakers.
- The supervised parent may not discuss the court case in any way in the child’s presence, nor allow anyone else to do so.
- The supervised parent may not be impaired by alcohol or drugs.
- The supervisor may interrupt or terminate the parenting time if the supervised parent does not honor the rules or limits set by the court or the supervisor.
- The supervisor shall report any child abuse witnessed or suspected.
- Nothing that happens during the parenting time is confidential and all information may be disclosed by the supervisor.

**OPTIONAL PROVISIONS (check as appropriate)**

\_\_\_\_ The supervisor is expected to keep written notes after each visit, particularly if a rule or limit is not honored by the supervised parent, to be shared with the court and both parents if requested.
