**NOTICE OF PUBLIC AVAILABILITY OF MODIFIED TEXT AND

Division 4. California Student Aid Commission  
Chapter 1. California Student Aid Commission  
Article 12.8. Learning-Aligned Employment Program (LAEP)

Amend Article 12.8, Sections 30600 through 30604, California Code of Regulations

Pursuant to the requirements of Government Code section 11346.8(c) and section 44 of Title 1 of the California Code of Regulations, the California Student Aid Commission is providing notice of text modifications to the proposed regulations for the Learning-Aligned Employment Program (LAEP). Pursuant to the requirements of Government Code sections 11346.8(d), 11346.9(a)(1), and 11347.1, the California Student Aid Commission is also providing notice that an Addendum to the Initial Statement of Reasons has been added to the rulemaking file and is available for public inspection and comment.

The Notice of Proposed Rulemaking for the originally proposed regulations was published in the Office of Administrative Law's California Notice Register on May 11, 2023 (Register 2023, No. Z-2023-0511-02S.) The 45-day comment period for the proposed regulations began on March 24, 2023, and ended on May 8, 2023.

**MODIFIED REGULATION TEXT**

Commission staff is now proposing revisions to the regulations as set forth in the attached Modified Regulation Text. The revisions are sufficiently related to the originally proposed text and are being provided for public review and comments for 15 days. All revisions are shown with single underline for new language and ~~single-strikeout~~ for deleted language.

**ADDENDUM TO THE INITIAL STATEMENT OF REASONS**

Commission staff has also drafted an Addendum to the Initial Statement of Reasons (ISOR). The Addendum includes supplemental information to better clarify and provide an expanded analysis of the purpose and necessity of the proposed text modifications.
