## **EXAMPLE OF HOW TO FILL OUT THE MARRIAGE CERTIFICATE - OFFICIANT**

This is an example of how to fill out the Marriage Certificate. The license and the certificate are on the same document. Do not separate them.

There are two categories of people who are authorized to sign the marriage certificate.

- A civil officiant such as a judge or magistrate.
- An officiant who has a religious ordination such as minister, pastor, reverend, priest, rabbi or monk.

"Officiant" or "Ordained" are not acceptable terms for the certificate.

If your officiant is not a judge/magistrate or does not have a religious ordination, you may sign the certificate as a self-solemnization. See instructions on page 2.

Witnesses are not required.

Within 63 days of completing the certificate, return the entire document to our office for recording. You can return it by mail or bring it to us in person. Late fees apply if returned after 63 days. If you would like certified copies for name changes, please send a check with your document. Certified copies are \$1.25 each. Check should be made payable to Manager of Finance.

THIS MARRIAGE CERTIFICATE MUST BE FORWARDED TO THE COUNTY CLERK AND RECORDER BY THE PERSON OR PARTY SOLEMNIZING THE MARRIAGE, WITHIN 43 DAYS OF SOLEMNIZATION. FAILURE TO DO SO SHALL RESULT IN A LATE FEE OF NOT LESS THAT 22 (TWENTY) DOLLARS, PAYABLE BY THE SOLEMNIZING FEESON OF PARTY. AN ADDITIONAL FIVE DOLLAR LATE FEE MAY BE ASSESSED FOR EACH ADDITIONAL DAY OF FAILURE TO COMPLY WITH THE FORWARDING REQUIREMENTS OF THIS SECTION (1) LIFT TO A MAJINUM OF FIRST DOLLARS, FOR PURPOSES OF DETERMINING WHETHER A LATE FEE SHALL BE ASSESSED PURSULANT TO THIS SUBSCITION (1), THE DATE OF FORWARDING SHALL BE DEEMED TO BE THE DATE OF THE POSTMARE. ## **Example of How to Fill Out the Marriage Certificate**

## **Self Solemnization**

This is an example of how to fill out the Marriage Certificate. The license and the certificate are on the same document. Do not separate them.

If your officiant is not a judge/magistrate or does not have a religious ordination, you may sign the certificate as a self-solemnization.

Your signatures must be the signature prior to the marriage and use the names listed on the marriage license.

Sign again on the party one Signature and Party Two Signature lines.

Witnesses are not required.

Within 63 days of completing the certificate, return the entire document to our office for recording. You can return it by mail or bring it to us in person. Late fees apply if returned after 63 days. If you would like certified copies for name changes, please send a check with your document. Certified copies are \$1.25 each. Check should be made payable to Manager of Finance.

RETURN TO THE OFFICE OF THE DENVER COUNTY CLERK AND RECORDER
THIS MARRIAGE CERTIFICATE MUST BE FORWARDED TO THE COUNTY CLERK AND RECORDER BY THE PERSON OR PARTY SOLEMNIZING THE MARRIAGE, WITHIN 43 DAYS OF SOLEMNIZATION.
FAILURE TO DO SO SHALL RESULT IN A LATE FEE OF NOT LESS THAT 20 (TWENTY) DOLLARS, BY THE SOLEMNIZING PERSON OR PARTY. AN ADDITIONAL FIVE DOLLAR LATE FEE MAY BE ASSESSED FOR EACH ADDITIONAL DAY OF FAILURE TO COMPLY WITH THE FORWARDING REQUIREMENTS OF FITH'S SUBSECTION (1) (1) IN TO A MAXIMUM OF FIFTY DOLLARS, FOR PURPOSES OF DETERMINING WHETHER A LATE FEE SHALL BE ASSESSED PURSUARY TO THIS SUBSECTION (1), THE DATE OF FORWARDING SHALL BE DEEMED TO BE THE DATE OF THE POSTMARE.
