### Executive Officer's Message

In my columns, I want to provide information about the Dental Hygiene Committee of California (DHCC). In my last column I provided a list of accomplishments. In this column, I want to explain the purpose of the DHCC and how we achieve it. I also want to inform readers about the DHCC's Sunset Review.

The DHCC is part of the Department of Consumer Affairs (DCA). The DCA is composed of more than 40 boards, bureaus, and agencies (e.g., Medical Board of California, Dental Board of California, Board of Accountancy, etc.) whose licensees provide services to California consumers. The primary purpose of each of these entities is to protect the public. The Department issues

## EXECUTIVE OFFICER'S MESSAGE (CONTINUED)

more than 2.8 million licenses, certificates, and approvals to individuals and businesses in more than 250 professional categories.

How does the DHCC protect the public? It does this two ways:

- 1) Ensuring that all licensees meet basic licensing requirements. These requirements include:
  - Successfully completing an educational program.
  - Passing a background check.
  - Passing a written examination that shows basic competency.
  - Passing a clinical examination (currently WREB, CRDTS, or the California Clinical).
- 2) Enforcing licensing requirements once an individual is licensed.

Each agency, including the DHCC, has rules that govern its operations. These rules can be divided into three categories:

- Statutes – Laws that are passed by the Legislature.
- Regulations – Government orders that have the force of law. Regulations are promulgated by an agency. Proposed regulatory language must be shared with the public and presented at a public hearing.
- Policy – A plan or course of action that determines decisions or actions. To ensure that good policy is developed, the DHCC holds two meetings a year. These meetings are open to the public and the agenda and all handouts are available on the DHCC website prior to the meeting.

As busy as the past four years have been, it seems that the pace of business will not slow down, especially since the DHCC will be undergoing a Sunset Review.

Sunset Review is an assessment of whether a State agency is necessary, effective, and efficient. Sunset Review is conducted pursuant to a sunset date – an expiration date for the agency. The review focuses on the overall necessity of the agency, its cost-effectiveness, and its measures of successes and failures. A Sunset Review report is prepared and presented to the Joint Legislative Sunset Review Committee (JLSRC) which is composed of five Assembly members and five Senators. The agency undergoes a hearing before the Committee and at the conclusion of the hearing, the Committee may:

- Let the agency expire at the sunset date.
- Continue the agency as-is.
- Make recommendations for improving operations.
- Suggest legislation to aid the agency's mandate.

The term “agency” is used to mean any governmental entity subject to sunset review. The JLSRC has jurisdiction over any agency, authority, board, bureau, commission, conservancy, council, department, division, or office of State government, excluding any agency that is constitutionally created or related to postsecondary education.

The JLSRC is mandated to review State government agencies, departments, committees, and commissions. The DHCC has been selected to participate in this review cycle to ensure that it is fulfilling its mission and operating effectively. The DHCC is scheduled for a hearing before the JLSRC on March 17, 2014.

## Reminders about citation and fine

As we reported in our last newsletter, new regulations effective December 14, 2012, allow the DHCC to issue a citation and a fine of up to \$5,000 for any violation of dental hygiene laws, including unlicensed practice, unprofessional conduct, failure to identify yourself in the patient record, or even minor violations such as not notifying the DHCC of a name change within 10 days or a change in address (including email address) within 30 days.

To help licensees notify the DHCC promptly of any name or address change and avoid being fined, here is the link to the Name Change and Address Change form:

Please keep in mind that we do not take address changes over the phone. All address changes must be submitted in writing.



## Changes in license applications and renewal fees

The Dental Hygiene Committee of California, like all other licensing entities within the Department of Consumer Affairs, is completely funded by the licensing and application fees paid by its applicants and licensees. To cover the cost of a licensing and enforcement program, it is necessary to periodically raise fees. Effective January 1, 2014, license application and renewal fees for RDH, RDHAP, RDHEF, and FNP will be raised to reflect the actual cost of providing these services. The fees are:

**LICENSE RENEWAL FEE**  
(effective January 1, 2014) **\$160**

**DELINQUENT RENEWAL FEE**  
(effective January 1, 2013) **\$80**



## Options for licensees when they retire

Many licensees have reached a point in their career where they are considering retirement. Currently, the DHCC does not have any provisions in law allowing its licensees to have a retired status for their license. As a result, one of the many decisions they need to make is: ***What do I do with my license?*** Licensees have the following three choices:

- 1. Continue to keep your license active** – simply continue taking the required continuing education classes (California Dental Practice Act, Infection Control, and a course in basic life support) and the required number of hours for renewal (25), complete the appropriate boxes (A or B and H or I) on the renewal form, pay the renewal fee, and return the renewal application in a timely manner.
- 2. Change your license to inactive** – simply mark the appropriate box (b - inactive), mark either box H or I, write a check to the DHCC, and mail your renewal application in a timely manner. If you choose to reactivate your license after you have changed it to inactive, you can visit the DHCC web home page ([www.dhcc.ca.gov](http://www.dhcc.ca.gov)), click on the “Forms and Publications” button and look for the Application to Activate/ Inactivate License ([http://www.dhcc.ca.gov/formspubs/app\\_activate.pdf](http://www.dhcc.ca.gov/formspubs/app_activate.pdf)) and follow the directions on this form. You may also wait until you receive your next renewal application form, mark the appropriate box, and enclose your check (payable to the DHCC).
- 3. Let your license lapse** – if you choose this option, you will receive only one more written notification. After five years of nonrenewal, your license will cancel and no longer exist. If you wish to practice again, you will need to complete all of the licensing procedures as though you were never licensed. You will also be required to meet any new licensing requirements that may have added since your initial licensure.

## Legislative Update

The DHCC tracked a number of bills this session, some of which were signed into law and became effective January 1, 2014. Here is an overview of some of the new laws:

- AB 512 extends the opportunity for out-of-state licensees to volunteer their services at sponsored free health events in California, allowing more services to be provided to those in need.
- SB 28 implements various provisions of the Affordable Care Act relating to determining eligibility for Medi-Cal.
- SB 562 requires the Dental Board of California to develop registration and operating regulations for mobile dental units and dental practices that routinely use portable dental units, and deletes restrictions limiting dentists to operating only one mobile dental clinic. This bill encourages access to care by allowing dentists to cover multiple sites with multiple mobile or portable units, either themselves or through the general supervision of dental hygienists.
- SB 809 establishes a funding mechanism to update and maintain the Controlled Substance Utilization Review and Evaluation System (CURES) and Prescription Drug Monitoring Program (PDMP), requires all prescribing healthcare practitioners to apply to access CURES information, and establishes processes and procedures for regulating prescribing licensees through CURES and securing private information.

The DHCC will continue to actively track two-year bills related to teledentistry (AB 318 and AB 1174), wellness programs (AB 771), health care coverage (SB 456), and expediting the licensure process for military spouses (SB 532), as well as any other bills of interest that are introduced.
