Per FPA 2618469 250 cy of spoils are proposed. This proposal is for the harvest of 0.7 acres of 40-50 year old timber for right-of-way and construction of approximately 1,350 feet of new forest road. Timber harvest and road construction will occur on a glacial deep-seated landslide. This feature is describe in the geotechnical report along with analysis and recommendation for protection of the unstable features. This proposal crosses two ownerships, Bogie Farms LLC and LC Restoration two separate Forest practices applications have been submitted.
