This proposal is to harvest approximately 46 acres of timber on steep slopes. A portion of this harvest will pass through a rule identified landform as defined in the Washington Forest Practices Board Manual. Mitigation measures for yarding through unstable features are as follows:

- 1) Any trees that are felled for yarding corridors will be left on site. To the extent practicable, trees in the yarding corridors will be felled sideways across the slope and left in place as cribbing to help minimize erosion and potentially stabilize the surrounding soil mass.
- 2) Individual yarding corridors will be cut as narrowly as possible and not exceed 30 feet in width. Yarding corridors should take advantage of natural openings in the forest stand wherever possible.
- 3) Any trees yarded through potentially unstable slopes will be bucked to no more than 40 feet in length prior to yarding. Full suspension yarding will be used, when possible, to minimize soil disturbance. Where full suspension cannot be achieved, slash or straw will be placed on disturbed soils to help prevent surface erosion.

The Natural Resources Conservation Service (NRCS 2024) has mapped two soil types within the proposed Huffmore harvest unit: steep Andic Xerumbrepts (3) and Boro very cindery sandy loam (25). See attached geotechnical report for more information.

Within the proposed harvest unit, there are no recent signs or history of unstable soils. Past and present soil movement in adjacent and nearby land forms is described in attached geotechnical report.

Two roads will be constructed within proposed harvest unit to facilitate logging and log haul. Full bench construction will be used where needed and the corresponding fill material will be used on adjacent road prisms. There is no expectation that fill material will be moved out of harvest unit. Crushed rock from nearby rock source may be brought in to surface roads.

Erosion could occur during the road construction and logging process.

Care will be taken to minimize erosion potential during the construction and logging process. Road locations have been placed away from streams to minimize sediment delivery, and logging around streams has been minimized.
