This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Forest Practice Application #2942749 proposal consists of 69.4 acres of even-aged timber harvest, salvage and fiber recovery, (totaling approximately 2,063 MBF and 290 tons). The proposal includes 212 feet of road construction and 240 cubic yards of spoils. Proposals for future activities related to this site may require additional SEPA review. Located in Section 32, Township 12 North, Range 07 West, and Section 05, Township 11 North, Range 07 West, W.M., Pacific County.
