This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Dabbler Timber Sale #106156 and Forest Practice Application #2942570 proposal is a variable retention harvest and right of way harvest with a total of 140 acres in 5 units, removing approximately 8,621 MBF of timber. The proposal includes 1,622 feet of road construction, 7,447 feet of road reconstruction, 25,449 feet of pre-haul maintenance, and 2,210 feet of abandonment. Located in Sections 35, 36, Township 06 North, Range 04 East, W.M., Clark County.
