This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Jackie Paper Timber Sale #106361 and Forest Practice Application #2942708 proposal is for a variable retention harvest with 89.6 acres in two units and 2.2 acres of right of way harvest in two units, for a total of 91.8 acres in four units, removing approximately 5,977 MBF of timber. The proposal includes 3,443 feet of road construction, 3,648 feet of road reconstruction and 17,472 feet of pre-haul maintenance. Located in Sections 30, 31, Township 17 North, Range 05 West, Sections 25, 36, Township 17 North, Range 06 West, and Section 01, Township 16 North, Range 06 West, W.M. Grays Harbor County.**
