AMENDED PROCES VERBAL OF TAX SALE

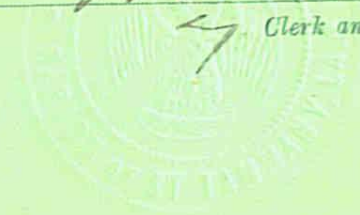

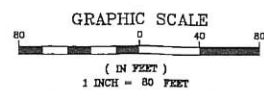
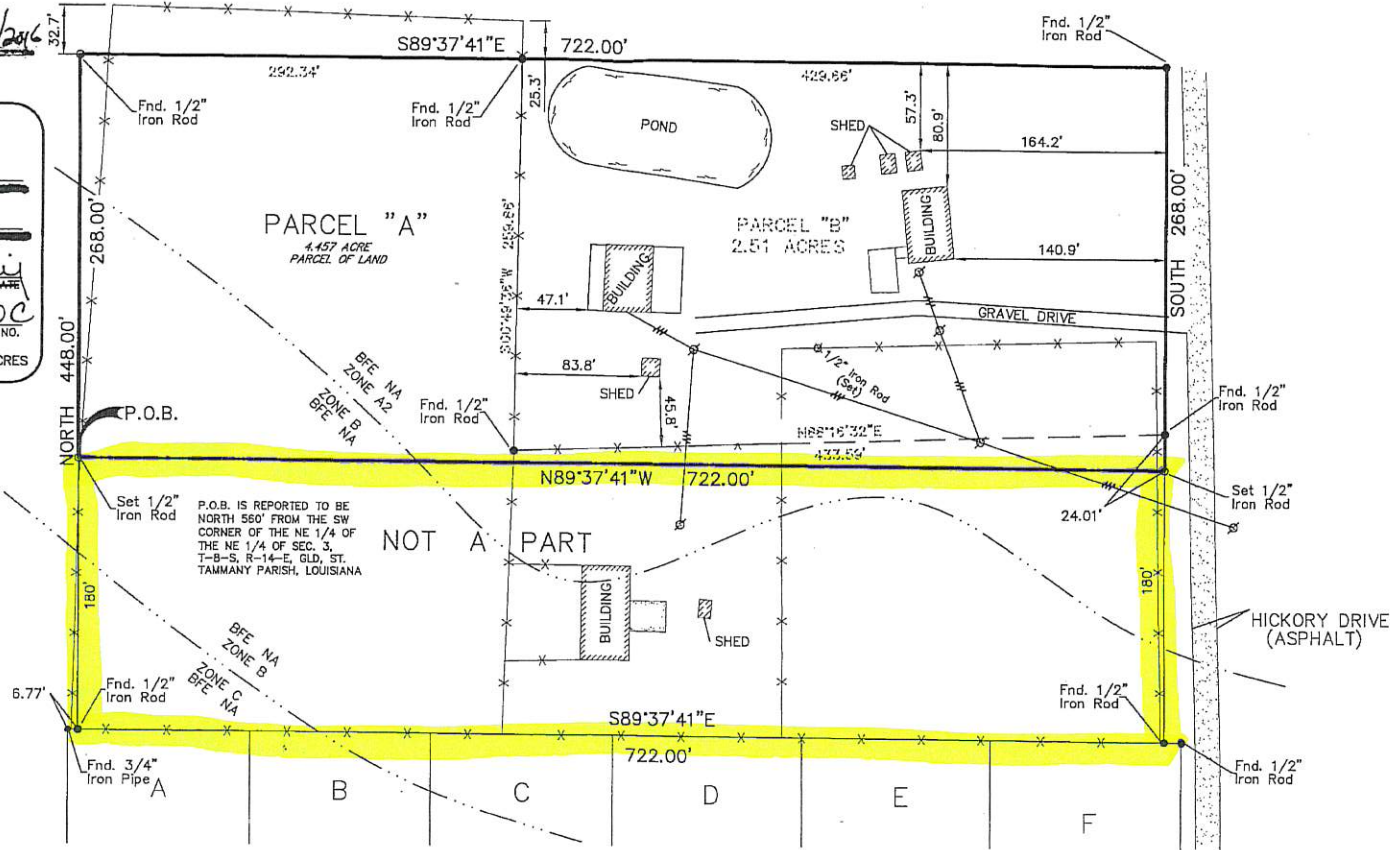
Legal Description Parcel A:

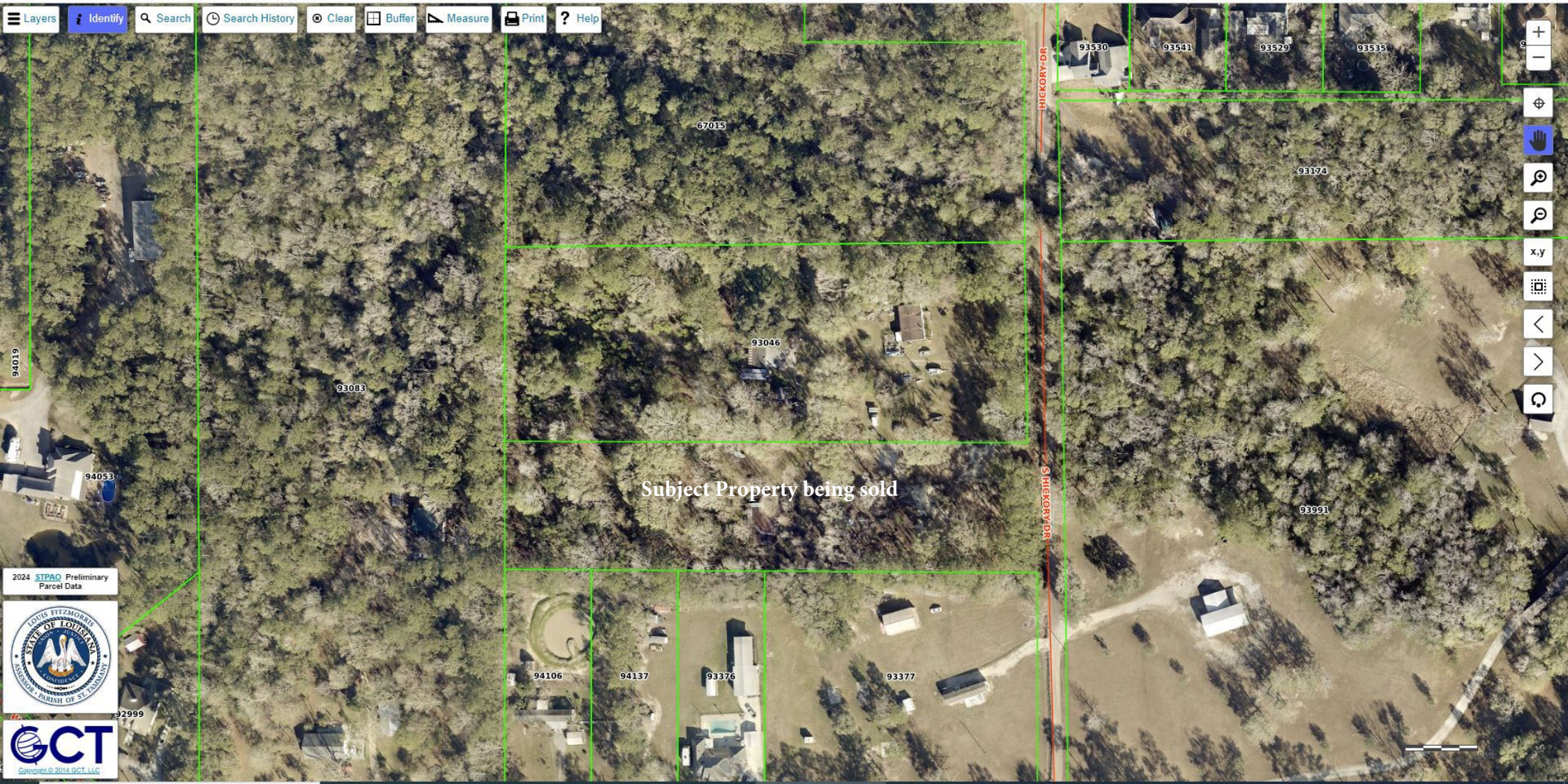
