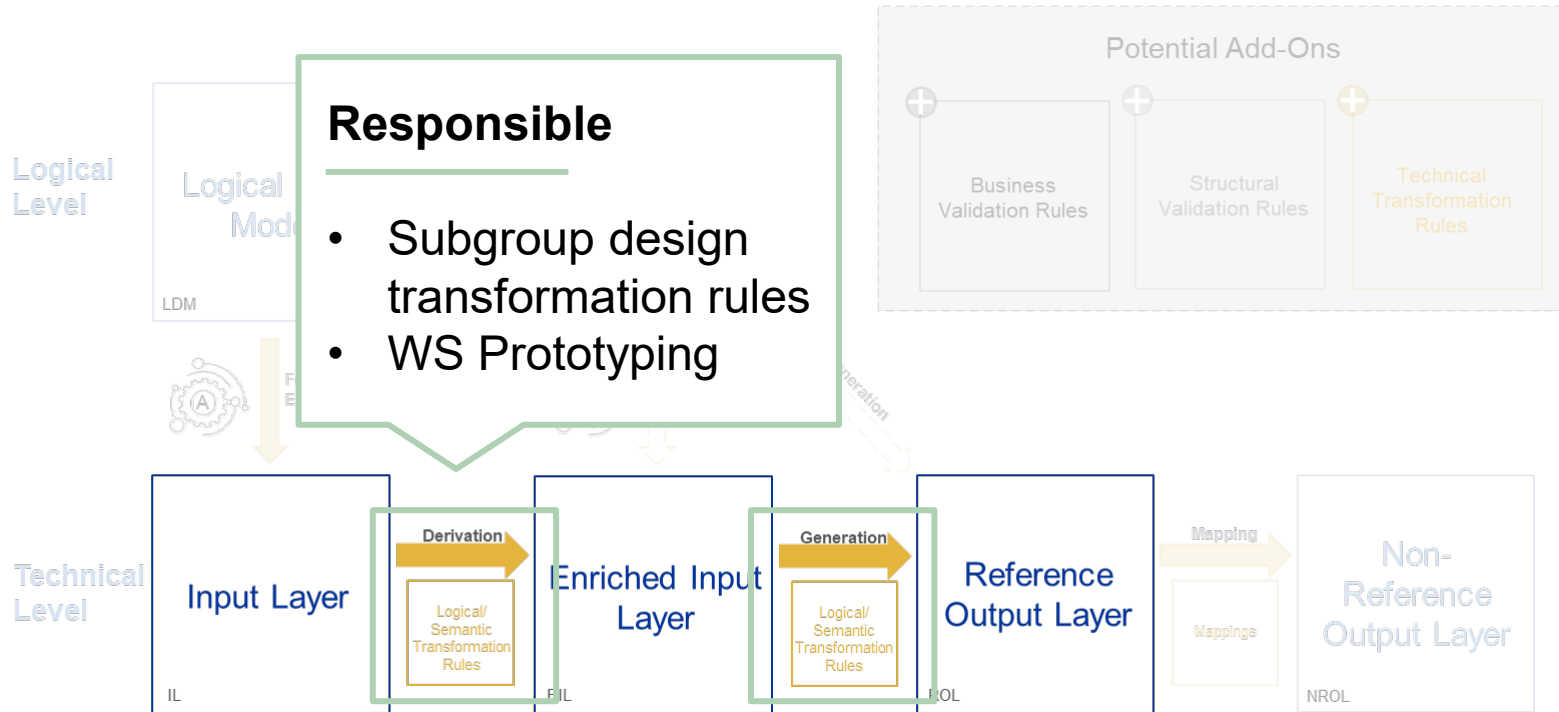
# The new BIRD process



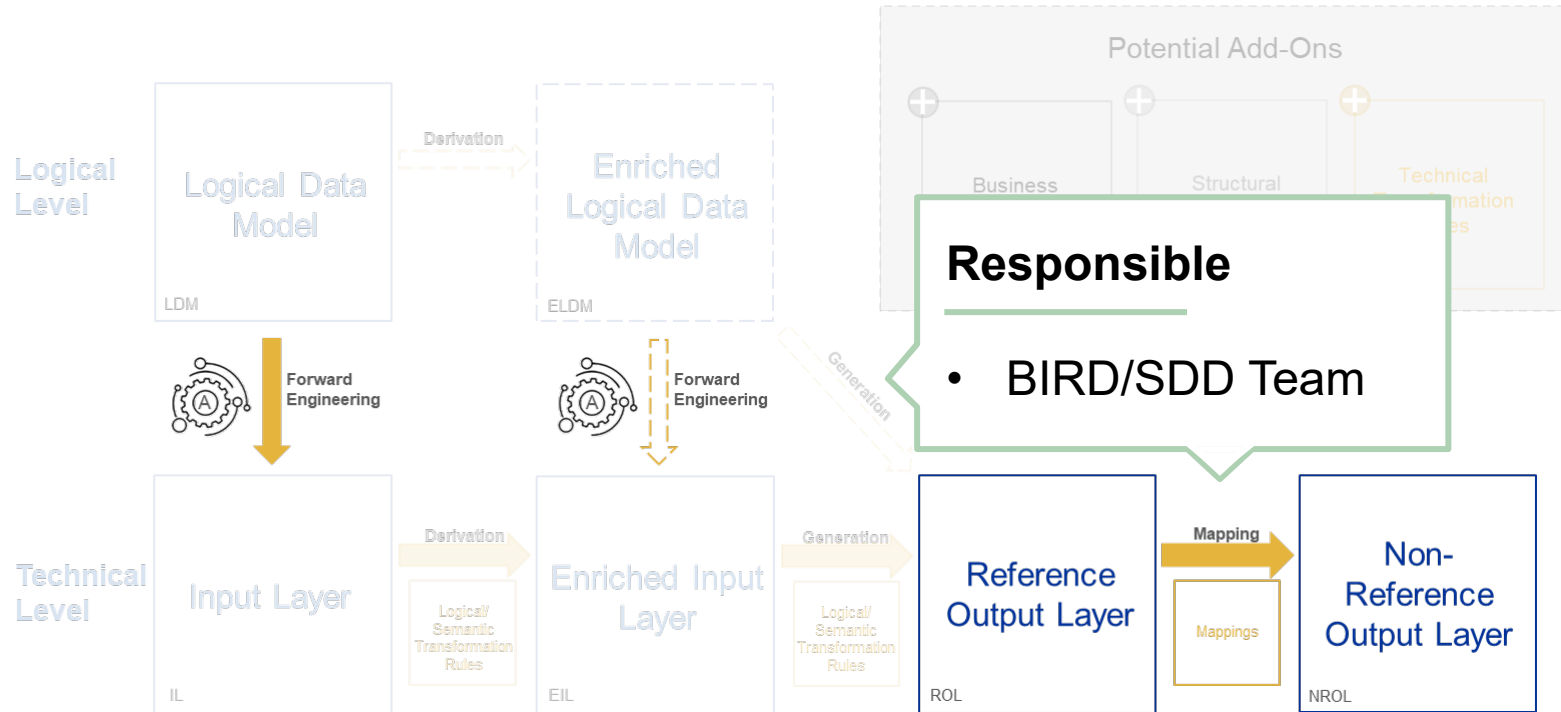
# Ongoing activities BIRD process (1)



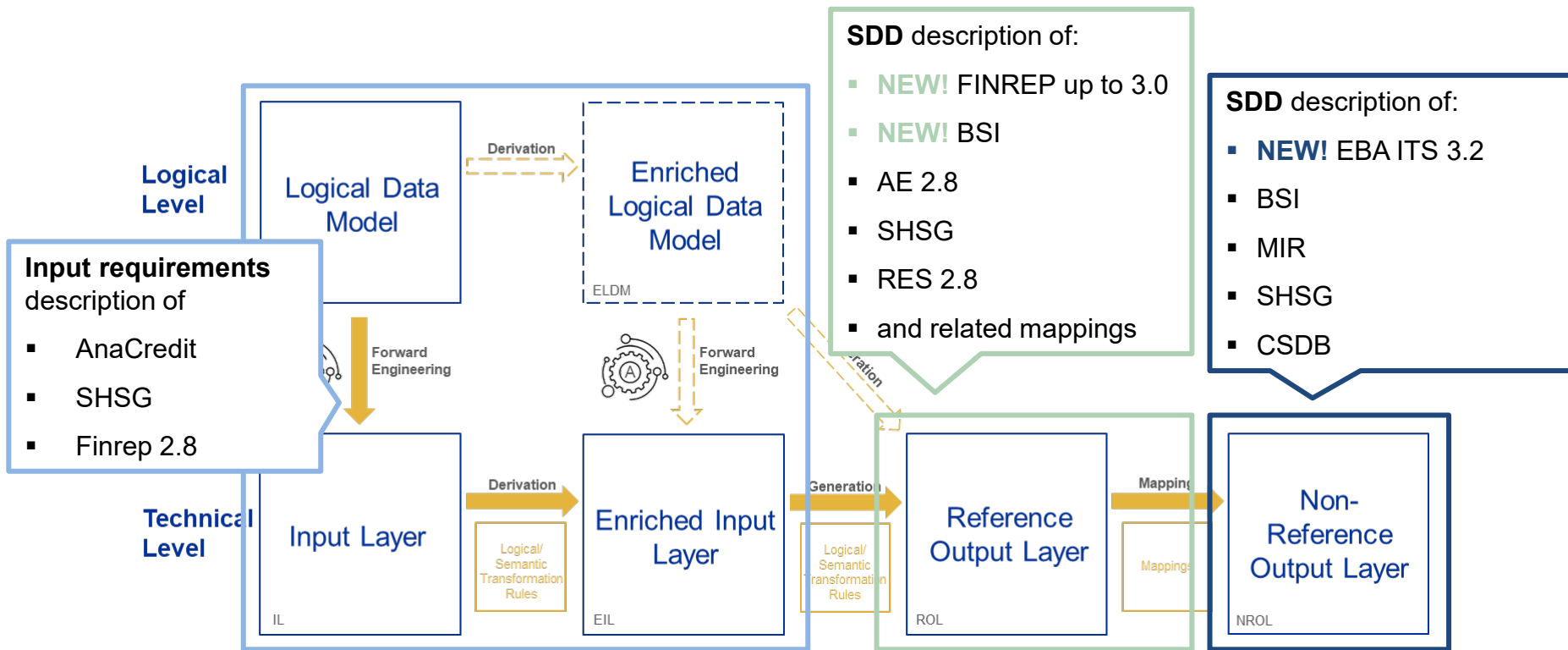

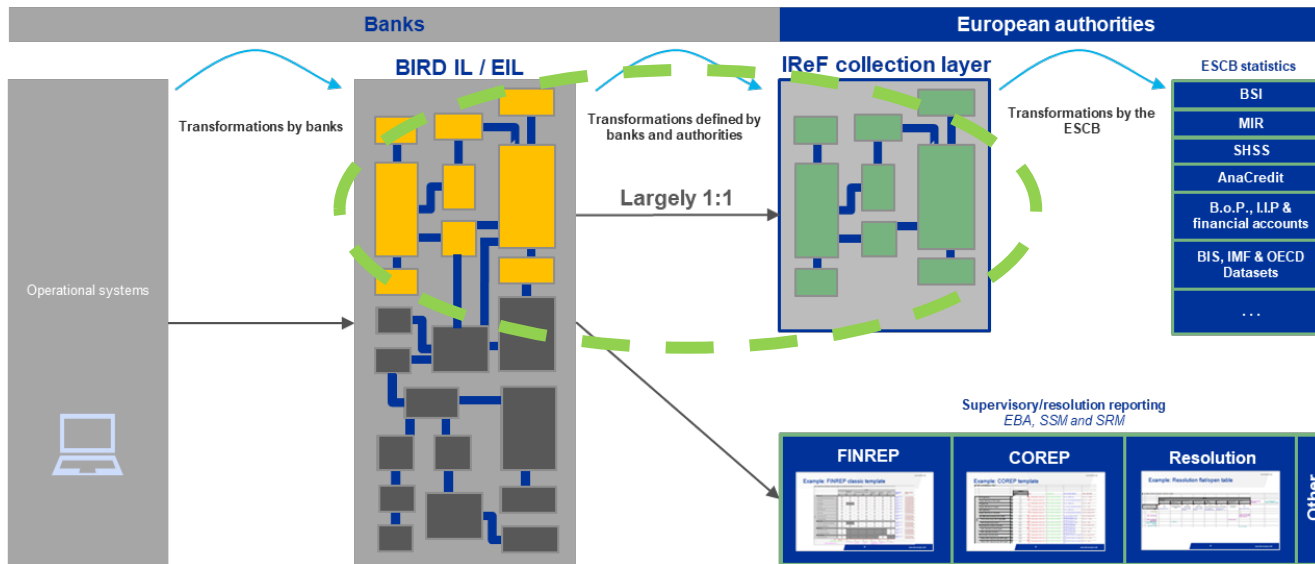
