The remaining states/areas are estimated based on various sources including first purchase volumes collected on Form EIA-182, *Domestic Crude Oil First Purchase Report*, state regulatory agencies, the Bureau of Safety and Environmental Enforcement (BSEE), Enverus, and S&P Global.
