By way of the attached Order, the Alaska Supreme Court has dismissed all of the appeals from Superior Court rulings on 07WATR and has vacated the Dillingham Superior Court ruling that 07WATR is appropriate for the ballot. Essentially, the Fairbanks Superior Court ruling—that prohibits the Lieutenant Governor from placing 07WATR on the ballot—remains in place. I will comply with these court orders, and this memorandum serves as my direction that 07WATR will not appear on the ballot.
