Re: 17FSH2, "An Act providing for the protection of wild salmon and fish and wildlife habitat."

Ms. Quinn-Davidson:

I have reviewed your petition for the initiative entitled "An Act providing for the protection of wild salmon and fish and wildlife habitat" and have determined that the petition was properly filed. My notice of proper filing is enclosed. Specifically, the petition was signed by qualified voters from all 40 house districts equal in number to 10 percent of those who voted in the preceding general election; with signatures from 40 house districts matching or exceeding seven percent of those who voted in the preceding general election in the house district. The Division of Elections verified 41,999 voter signatures, which exceeds the 32,127 signature requirement based on the 2016 general election. A copy of the Petition Statistics Report prepared by the Division of Elections is enclosed.

With the assistance of the attorney general, I have prepared the following ballot title and proposition that meets the requirements of AS 15.45.180:

An act providing for the protection of wild salmon and fish and wildlife habitat.

This act would amend Alaska's fish habitat permitting law. The act would require the Department of Fish and Game (ADF&G) to issue permits for activities and development projects that have the potential to harm fish habitat. The act would exempt existing projects, operations, or facilities that have received all state and federal permits. The act would create fish and wildlife habitat-protection standards. The standards would address water quality, temperature, streamflow, and more. The act defines "anadromous fish habitat." The act would allow ADF&G to apply the law to all habitat in Alaska that supports salmon or other anadromous fish. The act would provide for three types of permits for development in anadromous fish habitat. ADF&G could issue a general permit—a single permit that applies to many people—for certain activities. For other activities that require a permit, the act would establish a two-track permitting system. Minor permits would be issued for activities that have little impact on fish habitat. Major permits would be issued for projects that have the potential to cause significant adverse effects on fish habitat. The act defines "significant adverse effects." The act would require ADF&G to avoid or minimize adverse effects through mitigation measures and permit conditions. It would provide public notice on all permits and a chance to comment on major permits. The act would also require ADF&G to deny a permit if the proposed activity would cause substantial damage to fish habitat. The act would create criteria, timeframes, and an appeals process for the permits. The act would allow ADF&G to respond to permit violations with tickets, civil fines, or criminal penalties. The act would repeal two current statutes. One is regarding mitigation from a dam. The other is regarding criminal penalties that are addressed elsewhere.

Should this initiative become law?

This ballot proposition will appear on the election ballot of the first statewide general, special, or primary election that is held after (1) the petition has been filed; (2) a legislative session has convened and adjourned; and (3) a period of 120 days has expired since the adjournment of the legislative session. Barring an unforeseen special election or change in the scheduled adjournment of the current legislative session, this proposition is scheduled to appear on the election ballot on the August 21, 2018 primary election. If a majority of the votes cast on the initiative proposition favor its adoption, the proposed law is enacted, I shall so certify. The act becomes effective 90 days after certification.

Please be advised that under AS 15.45.210, this petition will be void if I, with the formal concurrence of the attorney general, determine that an act of the legislature that is substantially the same as the proposed law was enacted after the petition has been filed and before the date of the election. I will advise you in writing of my determination in this matter.

Please be advised that under AS 15.45.240, any person aggrieved by my determination set out in this letter may bring an action in the superior court to have the determination reversed within 30 days of the date on which notice of the determination was given.

I, BYRON MALLOTT, LIEUTENANT GOVERNOR FOR THE STATE OF ALASKA, under the provisions of Article XI of the Constitution of the State of Alaska and under the provisions of AS 15.45, hereby provide notice that the initiative petition for "An Act providing for the protection of wild salmon and fish and wildlife habitat", which was received on January 16, 2018, and known as 17FSH2, was properly filed.


I have determined that the initiative sponsors have timely filed the petition and that the petition is signed by qualified voters (1) equal in number to 10 percent of those who voted in the preceding general election; (2) resident in at least three-fourths of the house districts in the state; and (3) who, in each of the house districts, are equal in number to at least seven percent of those who voted in the preceding general election in the house district.

In accordance with AS 15.45.190, the Director of the Division of Elections shall place the ballot title and proposition on the election ballot of the first statewide general, special, or primary election that is held after a period of 120 days has expired since the adjournment of the legislative session. Barring any unforeseen special election or a change in the date of adjournment of the current legislative session, this proposition is scheduled to appear on the election ballot on the August 21, 2018 primary election.

Subject: 17FSH2 – An act providing for the protection of wild salmon and fish and wildlife.

The Division of Elections has reviewed signatures contained in the submitted petition booklets and has determined there are enough signatures from subscribers in support of this petition.

Per Article XI, Section 3 of the Alaska Constitution and AS 15.45.140, in order for an initiative to be deemed properly filed it must meet the following requirements:

1. Signed by qualified voters equal in number to 10 percent of those who voted in the preceding general election. The number of people voting in the 2016 general election was 321,271. To meet this requirement, the petition must have signatures from at least 32,127 qualified registered voters.
2. Signed by qualified voters resident in at least three-fourths of the house districts of the state. In order to meet this requirement, the petition must have signatures of voters from at least 30 house districts.
3. Signed by qualified voters in each of the required 30 house districts equal in number to at least seven percent of those who voted in the preceding general election.
4. The petition must be filed within one-year from the time the sponsors received notice the petition booklets were ready for delivery. To meet this requirement, the petition must have been filed by October 18, 2018.

The division has reviewed the signatures contained in the submitted petition booklets and have determined that the above requirements for this petition have been met as follows:

1. The petition contained signatures of 41,999 qualified registered voters.
2. The petition contained signatures of voters in all 40 house districts.
3. The petition contained signatures of qualified voters in all 40 house districts that equaled at least seven percent of those who voted in the preceding general election.
4. The petition was filed with the division on January 16, 2018.

For your review, I am attaching Petition Summary Report that reflects the total number of signatures statewide and by house district.
