### Preliminary Damage Assessment Report

# New Hampshire – Severe Storms and Flooding FEMA-4740-DR

### Declared September 14, 2023

On August 30, 2023, Governor Christopher T. Sununu requested a major disaster declaration due to severe storms and flooding during the period of July 9-17, 2023. The Governor requested a declaration for Public Assistance for nine counties and Hazard Mitigation statewide. During the period of July 24 to August 30, 2023, joint federal, state, and local government Preliminary Damage Assessments (PDAs) were conducted in the requested areas and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local governments, and that Federal assistance is necessary.<sup>1</sup>

On September 14, 2023, President Biden declared that a major disaster exists in the State of New Hampshire. This declaration made Public Assistance requested by the Governor available to state and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by severe storms and flooding in Belknap, Carroll, Cheshire, Coos, and Sullivan Counties. This declaration also made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.<sup>2</sup>

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

Minor Damage – home is damaged and uninhabitable, but may be made habitable in short period of time with repairs; and
