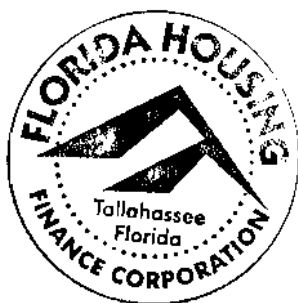
**ORDERED** that:


