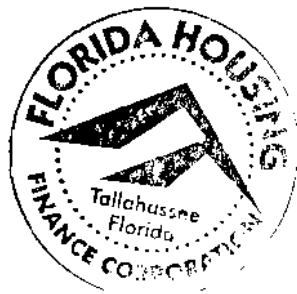
ORDER CLOSING FILE

Pursuant to your letter of July 2, 2008 (copy attached – Exhibit B, notifying me that a waiver from Rule 67-58.020(6) F.A.C. of the one percent (1%) extension fee, charged in conjunction with the granting of a ten-month extension by Florida Housing to complete credit underwriting for the Community Workforce Housing Innovation Pilot (CWHIP) Program, is an unnecessary procedure and, because of this determination, Florida Housing would not be imposing the one percent (1%) extension fee at this time, the Walton County Workforce Housing Corporation wishes to withdraw its petition filed June 6, 2008 (copy attached – Exhibit A) for a Waiver of Rules.
