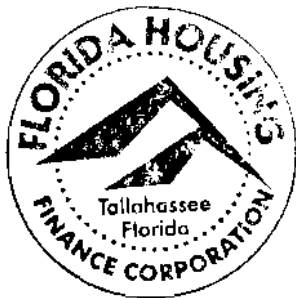
ORDER CLOSING FILE

2. The file of Florida Housing Finance Corporation in the above-captioned matter is hereby closed.



Petition for Waiver of Rule 67-48.004(14)(e).


