  - a. Retransmission of your simulcast signal by authorized recipients to secondary recipients is not allowable without disclosure within the contract of the names and locations of all secondary recipients.
  - b. The Board has the authority to audit the out-of-state receiving site's books and records (including all secondary sites that receive your simulcast) and must be noted in any simulcast agreement entered into for your simulcast signal. Included within the agreement must be reference that the guest shall permit inspection of the totalizator facilities at the site where guest's wagers are subject to commingling and all related totalizator books and records by a representative of the host or of the host's Board. Names and contact telephone numbers and/or addresses of managers at all pari-mutuel "hubs" used in the course of your simulcast transactions, if not included within individual contracts, must be supplied to the Board.
  - c. Any agreement which you are party to is subject to the requirements of the host and guest states with any provision mandated by either jurisdiction with such

- provisions specifically incorporated into contract by reference. Both parties, including any Secondary Recipients, shall comply with the provisions of all-applicable Federal, State and local laws and regulations.
- d. An SOC I Type II (formerly SAS-70 Type II) audit is to be performed for the current licensing period on the totalizator operations utilized and located at your facility. The report is to be filed with the Board no later than October 31, 2012.
- e. Rule 5100.2(b)(1), which requires that the track's totalizator system be in compliance with Rule 5100.24(l)-Independent Monitoring System.

The 2012 track and simulcast licenses are also conditioned on the following:

- Monticello Raceway and ERI shall continue to cooperate with staff in resolving the outstanding issues relating to the Bryanston/Tollman and Garland Business Corp. shares;
- Monticello Raceway and ERI shall immediately notify the Board in writing in the event of changes of any facts or circumstances set forth in Monticello Raceway's April 23, 2012 letter.

#### 2. WESTERN REGIONAL OTB – NEW EZ-BET – DANNY'S RESTAURANT - BUFFALO

The New York State Racing and Wagering Board approved an amendment to the Western Regional Off-Track Betting Corporation simulcast plan of operation to authorize the operation of an EZ Bet simulcast facility located in Danny's Restaurant, 3715 Genesee St., Cheektowaga, NY.

# 3. WESTERN REGIONAL OTB/BATAVIA DOWNS – REPLACEMENT OF ROOF SIGNAGE AS PART OF THE RELOCATION OF VIDEO GAMING ACTIVITIES TO THE FIRST FLOOR

The New York State Racing and Wagering Board approved the request of Suffolk Regional Off-Track Betting Corporation to amend its plan of operation to reflect the appointment of Philip C. Nolan to the position of President of Suffolk Regional Off-Track Betting Corporation effective July 1, 2012.

#### 5. SARATOGA HARNESS – 9 HORSE FIELDS

The New York State Racing and Wagering Board authorized Saratoga Harness Racing, Inc. to use nine (9) horse fields in overnight races during the 2012 racing season at Saratoga Gaming and Raceway, subject to conditions set forth in the Directive dated May 30, 2012.

### 6. BUFFALO RACEWAY – REQUEST TO AMEND PLAYER REWARDS PROGRAM

The New York State Racing and Wagering Board approved Buffalo Trotting Association Inc.'s request to amend its player rewards program to allow:

Members wagering \$5,000 or more in one business day will receive two (2) rewards points for every dollar wagered on participating in-state and out-of-state thoroughbred races and two (2) rewards points for every dollar wagered on participating in-state and out-of-state harness races net of refunds.

### 7. CATSKILL REGIONAL OTB – AMENDMENT AND EXTENSION OF TOTE AGREEMENT

The New York State Racing and Wagering Board approved the totalisator agreement dated November 4, 2009 between the Catskill Regional Off-Track Betting Corporation and Sportech Racing, LLC (formerly Scientific Games Racing, LLC).

#### 8. FIVE YEAR REVIEW OF RULES FOR CALENDAR YEARS 1997, 2002 AND 2007

Pursuant to Section 207 of the State Administrative Procedure Act, the New York State Racing and Wagering Board approved the continuation without modification of the rules adopted in 1997, 2002 and 2007.

#### 9. PROPOSED RULEMAKING – RACING REIMBURSEMENT FEE – HARNESS RACING

The New York State Racing and Wagering Board approved the proposal to add new Section 4101.41 to 9E NYCRR of the Board's harness rules. This amendment implements Part Y of Chapter 58 of the Laws of 2012 pursuant to which the costs for one associate judge and the starter will be reimbursed by each licensed racing corporation where the associate judge or starter is employed.

### 10. NOTICE OF ADOPTION - AMENDMENT OF HORSE RACING RULES PURSUANT TO MARRIAGE EQUALITY ACT OF 2011

The New York State Racing and Wagering Board approved amendments to Sections 4002.14(b), 4100.1(a)(44), 4102.3(d), 4205.6(b) and 4205.1(g) of 9 NYCRR to remove any references in the Board's rules that could give the appearance of unequal treatment of persons in a different-sex and same-sex marriage.

#### 11. IN THE MATTER OF RYAN CURATOLO

The New York State Racing and Wagering Board accepted the recommendation of Hearing Officer Clemente J. Parente that the seven (7) day license suspension of Ryan Curatolo for riding carelessly during the running of the 10<sup>th</sup> race at Belmont Park on May 29, 2011, in violation of Board Rule 4035.2(d), be upheld.

#### 12. IN THE MATTER OF JUSTIN B. MEAGHER

The New York State Racing and Wagering Board upheld the recommendation of Hearing Officer Clemente J. Parente and suspended the harness owner's license of Justin B. Meagher pending disposition of pending criminal charges with revocation if he is convicted of any of the pending charges.
