For entry into the minutes, on August 15, 2012, the New York State Racing and Wagering Board approved the adoption by emergency rule making of add new section 4101.41 to 9E NYCRR of the Board's harness rules. This amendment implements Part Y of Chapter 58 of the Laws of 2012. Under Chapter 58, the costs for one associate judge and the starter will be reimbursed by each licensed racing corporation where the associate judge or starter is employed.

8. VERNON DOWNS – REQUEST FOR TEMPORARY LICENSING EXEMPTION AND SECTION 322 PERMIT FOR BRUCE SPRINGSTEEN CONCERT ON AUGUST 29, 2012

For entry into the minutes, on August 17, 2012, the New York State Racing and Wagering Board (Board) approved the Vernon Downs request by letter dated July 6, 2012 and subsequent correspondence to provide an exemption from licensing requirements for the Bruce Springsteen concert personnel that are to be on the grounds between August 24, 2012 and August 31, 2012. This approval was conditioned on strict adherence to the procedures set forth in the correspondence and the requirement that Vernon Downs submit a complete list of names of persons seeking a licensing exemption by August 24, 2012.

Also, pursuant to Section 322 of the New York State Racing, Pari-Mutuel Wagering and Breeding Law, the Board granted a permit for construction related to the event. This approval was limited to the scope of the permit issued by the Town of Vernon.

9. NYRA – REQUEST FOR TEMPORARY APPROVAL - ADDITIONAL CALL CENTER

For entry into the minutes, on August 23, 2012, the New York State Racing and Wagering Board (Board) approved the New York Racing Association, Inc. (NYRA) request for partial utilization of the Portland, Oregon call center on August 25, 2012 pursuant to its application and subsequent correspondence with Board staff. The approval was conditioned on NYRA filing a report with the Board no later than close of business August 29, 2012 indicating the volume of calls and handle wagered at the Amherst, New York call center and the same at the Portland, Oregon call center.

D. ITEMS APPROVED, DENIED OR DEFERRED BY THE BOARD

1. OSWEGO RACING, INC. - CERTIFICATE OF INCORPORATION

Pursuant to Racing, Pari-Mutuel Wagering and Breeding Law Section 302, the New York State Racing and Wagering Board approved and indorsed the certificate of incorporation of Oswego Racing, Inc., thus permitting its filing with the New York State Department of State.

2. SARATOGA HARNESS – AMENDMENT TO CERTIFICATE OF INCORPORATION

The New York State Racing and Wagering Board approved an amendment to the certificate of incorporation of Saratoga Harness Racing, Inc. to change the purposes clause by adding a new subparagraph (i) to paragraph 2 as follows:

"(i) To lend money to or guarantee the obligation of any director, officer or shareholder of the Corporation provided that the Board of Directors determines that the loan or guarantee benefits the Corporation and either approves the specific loan or guarantee or general plan authorizing loans and guarantees."

- 3. SARATOGA HARNESS REQUEST TO IMPLEMENT NEW WAGER PICK 5 The New York State Racing and Wagering Board (Board) approved the request dated August 6, 2012 from Saratoga Casino and Raceway (SCR) to implement a Pick 5 wager. Approval is conditioned on compliance with the following:
 - The Pick 5 shall be conducted according to the submitted application and referenced rule (Method 7, Pick (n) with No Minor Pool and Carryover).
 - SCR shall provide a copy to the Department of Taxation and Finance for their review of all end of day wagering reports from the first day the Pick 5 is offered.
 - SCR shall notify the Board when it terminates the guaranteed amount.
 - SCR must provide notice of the Pick 5 rules in a prominent manner for the benefit of the wagering public.

4. 2011 MAINTENANCE OF EFFORT PAYMENTS 1017.2.a AND ADDITIONAL PAYMENTS 1017.2.b

The New York State Racing and Wagering Board (Board) approved the schedules referenced in Section 1017.2.a of the Racing, Pari-Mutuel Wagering and Breeding Law that each off-track betting corporation submitted to the Board for 2011.

The Board directed and required that these payments be made no later than thirty (30) calendar days after August 30, 2012.

The aggregate nighttime thoroughbred handle for the OTBs was less than One Hundred Million Dollars for the year therefore no additional payments are due any regional tracks under 1017.2.b.

- 5. CAPITAL DISTRICT REGIONAL OTB NEW MEMBER TO BOARD OF DIRECTORS FOR ALBANY COUNTY – ARNOLD MENDOZA The New York State Racing and Wagering Board approved the Capital District Regional Off-Track Betting Corporation request to amend its plan of operation to reflect the appointment of Mr. Arnold Mendoza as Albany County's representative to the Capital District Regional Off-Track Betting Corporation's Board of Directors.
- 6. NASSAU REGIONAL OTB REQUEST TO AMEND ACCOUNT WAGERING PLAN OF OPERATION – CHANGE OF ELECTRONIC SIGNATURE VENDOR The New York State Racing and Wagering Board approved the Nassau Regional Off-Track Betting Corporation request to amend its account wagering plan of operation to reflect the change of its electronic signature vendor as provided for in its June 20, 2012 application and subsequent correspondence with staff.
- 7. NASSAU REGIONAL OTB REQUEST TO AMEND ACCOUNT WAGERING PLAN OF OPERATION – INCREASE ACH LIMITS The New York State Racing and Wagering Board approved the Nassau Regional Off-Track Betting Corporation request to amend its plan of operation to increase its

immediate available funds policy as provided in its June 29, 2012 application and subsequent correspondence with staff.

- TIOGA DOWNS REQUEST FOR APPROVAL OF TOTALISATOR AGREEMENT WITH UNITED TOTE The New York State Racing and Wagering Board approved the totalisator agreement dated June 1, 2012 between American Racing-Tioga Downs, Inc. and United Tote Company.
- 9. VERNON DOWNS REQUEST FOR APPROVAL OF TOTALISATOR AGREEMENT WITH UNITED TOTE

The New York State Racing and Wagering Board approved the totalisator agreement dated June 1, 2012 between American Racing-Vernon Downs, Inc and United Tote Company.

10. NOTICE OF ADOPTION – MAXIMUM FINE AMOUNTS IN HORSERACING The New York State Racing and Wagering Board approved the adoption of amendments to the Board's thoroughbred, harness and quarterhorse racing rules to raise the maximum allowable fines from \$5,000 to \$25,000 based on statutory amendments in Chapter 240 of the Laws of 2010.

11. NOTICE OF ADOPTION – REIMBURSEMENT RULE FOR HARNESS RACING OFFICIALS

The New York State Racing and Wagering Board approved the adoption of new Section 4101.41 to 9E NYCRR of the Board's harness rules. This amendment implements Part Y of Chapter 58 of the Laws of 2012 pursuant to which the costs for one associate judge and the starter will be reimbursed by each licensed racing corporation where the associate judge or starter is employed.

12. IN THE MATTER OF JOHN CUMMINGS, JR.

The New York State Racing and Wagering Board adopted the recommendation of Hearing Officer Clemente J. Parente that the thirty (30) day license suspension of John Cummings, Jr., because he drove the horse Mr. Rickey N in the 4th race on July 16, 2011 "with a design not to win or in a manner inconsistent with an attempt to win", in violation of Board Rule 4117.4 (n), be upheld.

13. IN THE MATTER OF STEVEN P. COHEN

The New York State Racing and Wagering Board upheld the recommendation of Hearing Officer, Clemente J. Parente to uphold the denial of a harness racing general services license to Steven P. Cohen based upon findings that he made a false statement on his license application regarding his criminal history and that Mr. Cohen's experience, character and general fitness are such that his participation in racing is inconsistent with the public interest, convenience and necessity, or with the best interests of racing generally.

14. IN THE MATTER OF SALVATORE V. MARCHESE

The New York State Racing and Wagering Board dismissed the appeal from the denial of the harness trainer-farrier license of Salvatore V. Marchese as untimely.

15. SUFFOLK REGIONAL OTB – QWIK BET TOMMY'S PLACE AT ROCKY POINT – NEW OWNER – DANIEL PESCE – NEW NAME FOR FACILITY – CARMODY'S

The New York State Racing and Wagering Board approved an amendment to the Suffolk Regional Off-Track Betting Corporation simulcast plan of operation authorizing the operation of a Qwik Bet simulcast facility located in Carmody's, 42 Broadway Rocky, Point, New York. This location was formerly known as Tommy's Place at Rocky Point and was previously approved by the Board on April 30, 2009.
