1. NOTICE OF EMERGENCY RULEMAKING – THOROUGHBRED RACING CLAIMING RULE

For entry into the minutes, on August 31, 2012, the New York State Racing and Wagering Board approved the adoption by emergency rule making of a revision to subdivision (a) of Section 4038.5 of the Board's thoroughbred racing rules. This amendment provides that a claim shall be void for any horse that dies during a race or is euthanized on the track following a race.

2. YONKERS RACEWAY – EMPLOYEE APPRECIATION DAY CONSTRUCTION PERMIT

For entry into the minutes, on September 7, 2012, the New York State Racing and Wagering Board approved the construction work related to the Employee Appreciation Day Barbeque that was held at Yonkers Raceway on August 29, 2012. This request was approved pursuant to section 322 of the New York State Racing, Pari-Mutuel Wagering and Breeding Law.

3. NOTICE OF EMERGENCY RULEMAKING – PURSE PROPORTIONALITY RULE IN CLAIMING RACES

8. WESTERN REGIONAL OTB – NEW EZ-BET – VILLAGE ROCK CAFÉ - EAST ROCHESTER

The New York State Racing and Wagering Board approved an amendment to the Western Regional Off-Track Betting Corporation simulcast plan of operation to authorize the operation of an EZ Bet simulcast facility located in Village Rock Café, 213 E. Main Street, East Rochester, NY.

9. WESTERN REGIONAL OTB – NEW EZ-BET – MARGER, INC. dba CRUISER'S – NIAGARA FALLS

The New York State Racing and Wagering Board approved an amendment to the Western Regional Off-Track Betting Corporation simulcast plan of operation to authorize the operation of an EZ Bet simulcast facility located in Cruiser's, 9799 Porter Road, Niagara Falls, NY.

10. NOTICE OF ADOPTION - THOROUGHBRED RACING CLAIMING RULE

The New York State Racing and Wagering Board approved the adoption of an amendment to subdivision (a) of Section 4038.5 of the Board's thoroughbred racing rules. This amendment provides that a claim shall be void for any horse that dies during a race or is euthanized on the track following a race.

11. NOTICE OF ADOPTION - TCO2 2012 RULE AMENDMENTS

The New York State Racing and Wagering Board approved the adoption of amendments to 4043.8 (a), (b) and (e); 4043.9 (a) and (b); 4120.13 (a), (b) and (e);

4120.14 (a) and (b); 4043.9(c) and 4120(c) of the Board's rules regarding procedures and penalties for the testing of thoroughbred and harness race horses for the presence of excess total carbon dioxide (TCO2) levels.

12. IN THE MATTER OF DENIS CORTES

The New York State Racing and Wagering Board accepted the recommendation of Hearing Officer Clemente J. Parente that the thoroughbred racing general services license of Denis Cortes be revoked based upon a positive human drug test and his failure to comply with the terms of his Consent to Conditions for Reinstatement in violation of Board Rules 4042.5(a) and (c) and the findings that under the circumstances, Mr. Cortes lacks the general character and fitness for continued participation in pari-mutuel racing and his continued participation in pari-mutuel racing is inconsistent with the public interest, convenience, and necessity, and with the best interests of racing generally.
